Subject: Minutes of the 3rd Meeting of the Project Review and Steering Group (PRSG) for the 2 Meity Schemes – (i) "Scheme for financial assistance to select States/UTs for Skill Development in Electronics System Design and Manufacturing (ESDM) Sector" (Scheme-1) and (ii) "Skill Development in ESDM for Digital India" (Scheme-2).

The 3rd meeting of the Project Review and Steering Group (PRSG) to review the two Schemes of MeitY on Skill Development in ESDM Sector was held on 28th November, 2018 at 11:00 Hrs in Conference Hall number 1007, Electronics Niketan, 6, CGO Complex, Lodhi Road, New Delhi under the chairmanship of Dr. Jaideep Kumar Mishra, Joint Secretary, MeitY. The list of participants is placed at *Annexure-I*.

- 2. At the outset, Shri A.K. Pipal, HoD, HRD Division, MeitY informed the PRSG about the agenda of the meeting. Thereafter, the Chairman welcomed the participants and informed that as fresh enrollments are to be resumed shortly, emphasis has been made to inculcate greater quality in training & placements to ensure that the outcomes of the Schemes are achieved. He further said that all stakeholders must jointly make efforts and ensure that the ESDM Schemes are able to meet the larger societal objectives of training and employment in the fast growing segment of Electronic System Design & Manufacturing in the country. Thereafter he invited Shri Sanjay Kumar Vyas, Additional Director, MeitY to further elaborate upon the two ESDM Schemes.
- 3. Shri Vyas informed the Committee that efforts have been made to incorporate value-added features in the ESDM Schemes pertaining to industry based demands in the ESDM sector. As a result of the deliberations held in the Expert Committee meeting in July, 2018, the Administrative Approvals of both the schemes have been suitably amended to include allocation of training seats based on industry collaboration and demands for skilled manpower in these areas. Sixty percent (60%) of new enrollments would now be based on proposals that takes into account collaboration with industry and projected assurances pertaining to employability of successful candidates. He further said that the process pertaining to monitor the employability status of successful candidates by TP/KIA/SIA has also been streamlined and SIA's/ KIA's can also place candidates and claim benefits, in case their TPs are unable to do so within a reasonable time. He then requested the NIELIT-PMU to present the progress of the Schemes besides the highlights of the revised guidelines. Thereafter the agenda items may be taken up for discussions by PRSG.
- 4. Shri Mohit Jain, Senior Consultant, PMU presented the physical and financial progress of Scheme-1 and Scheme-2. He informed that in Scheme-1, out of a total target of 90,000, so far a total of 43,318 candidates have been trained, out of which 30,838 have been certified. For Scheme-2, out of a total target of 3,28,000, so far a total of 2,40,311 candidates have been trained out of which 1,64,602 have been certified. Thus for both the Schemes, a total of 2,83,629 candidates have been trained and 1,95,440 candidates have been certified so far, as per the following breakup:

- 5. The PRSG was also informed about the following key highlights pertaining to the Revised Guidelines based on amendments in the Administrative Approvals of the Schemes, which have been notified in November 2018:
- 5.1 While 'Make-in-India' policy has spurred demands of skilled engineers, however, due to lack of appropriate skills, some engineering graduates find it difficult to obtain jobs. Hence the Schemes would now permit engineering graduates to undergo training under Level-5 Courses.

- PRSG was also informed that while 80% of the fees pertaining to training are claimed by the TPs, the remaining 20% pertaining to placement/ employability is generally not claimed as only a handful of TPs are able to successfully place their candidates. Thus to mitigate the said issue, the process has been suitably amended. The respective TP will have the first right to place the candidate subject to a time frame of 2 months after certification. In case, the TP is not able to place the candidates within the stipulated time, the respective KIA/SIA (on first-cum-first basis) will have the right to place the candidate subject to a further time frame of 2 months and claim the remaining 20% fee related to placements.
- 5.3 Henceforth 60% of the seats would be allocated based on demand-based proposals. KIAs, in consultation with industry and TP would submit proposals as per Proforma, as already circulated in the revised guidelines. Such proposals would also include the details of tie-ups with Industry/ Firms where the candidates are likely to be placed. These proposals may also indicate the category under which training is proposed, i.e., 'Place & Train' or Train & Place' and preference for allocation would take into account reasonable assurances of employability. The remaining 40% seats are to be allocated for Service Sector (Repair/ Maintenance) courses to boost Entrepreneurship/ Self-Employment.
- 5.4 Code of Ethics, including undertakings from stakeholders has also been defined in the revised guidelines and the same may be adhered to in both letter and spirit.
- 5.5 The remaining target for both Schemes for FY2018-19 is as follows:

- 6. Thereafter, the Agenda items were taken up. The deliberations held along with the recommendations of the PRSG are summarized as under:
- Rationalization of Courses & Benchmark for 40% Seat Allocation: While 60% of the training seats would be based on demand-based proposals, it was also discussed that for allocation of 40% training seats to boost entrepreneurship and self-employment, a need is felt to monitor and rationalize Training Partners based on their past credibility in promoting employability of its candidates. In this regard, it was also suggested that preference should be accorded by SIAs/ KIAs to those TPs where 'trained vis-à-vis placed' ratio, based on past data, are analyzed and are found to be appropriate as per benchmarks defined by the respective KIAs. Such ratio may also take into account, data references with regard to employability of candidates in respect of other Government Schemes (such as PMKVY), which the TPs may also be implementing.

Recommendation: With a view to rationalize the ESDM Course basket, PRSG recommended that SIAs/ KIAs may analyze and provide a list of courses to NIELIT-PMU that have high demands, training-placement ratio, etc. On similar lines, KIAs/ SIAs may also suggest inclusion of new ESDM courses that are NSQF compliant. Further KIAs/ SIAs may recommend allocation of seats to TPs based on their internal benchmarks so that employability of the successful candidates can be ensured.

Internal Sub-Head readjustment for PMU, MIS, Awareness/ Mobilization Funds: PRSG was informed that as per Administrative Approvals, the Budget for internal sub-heads for PMU, MIS, Awareness/ Mobilization funds under Scheme-1 is Rs. 336.87 Lakh and for Scheme-II is Rs. 858.76 Lakh. The budgets are divided into various sub-heads. Taking into account the actual sub-head wise expenditure till 31-Mar-2018 a need has been felt for readjustment of budget heads pertaining to for the PMU, MIS, and Awareness/mobilization funds for remaining duration of the Scheme, as per the details at *Annexure-II*.

Recommendation: The PRSG recommended the readjustment in sub-heads, as indicated at Annexure-II, at no cost escalation.

6.3 Mid-term Review/ Impact Assessment: The PRSG was apprised that C-DAC Noida had undertaken the Mid-term Review/ Impact Assessment of the Schemes and thereafter the officials from C-DAC, Noida presented its findings of the Final Report to the PRSG. PRSG observed that at the time of assigning the task of carrying out the Mid Term Review/ Impact Assessment of the two Schemes, the enrolments in the Schemes were on-hold and therefore CDAC was not in a position to include their findings with respect to the actual trainings being conducted.

Recommendation: PRSG after deliberations recommended that the Final Report be accepted on suitable incorporation by CDAC with regard to their observations connected with visit to actual Training Partners on resumption of enrolment. PRSG further recommended that a summary of findings may be circulated to SIAs and KIAs.

Financial Status & Release of Funds: The financial status of both the schemes was presented. PRSG was informed that under Scheme-1, around Rs. 27.05 Cr. have been released as GIA to State Implementing Agencies (SIAs) & NIELIT. It was further informed that in Scheme-2, around Rs. 134.96 Cr. has been released as GIA to NIELIT. As on date, details of GIA released to each stakeholder and the status of Utilization Certificate (UC) is at *Annexure-III*.

Scheme-I: The PRSG was further informed that the fund requirement for SIAs based on the state-wise targets for FY 2018-19 and revised Course Fee is around Rs. 29.47 Cr. and fund requirements for NIELIT on account of RCCF based on FY 2018-19 targets is around Rs.2.84 Cr., as per details placed at *Annexure-IV*. Thus, a total of Rs. 33.30 Cr. is sought for immediate release, which includes Rs. 0.18 Cr. for final payment towards Impact Assessment to C-DAC and Rs. 0.81 Cr. to NIELIT towards PMU/MIS/Awareness/ Mobilization.

Scheme-II: With regard to release of payments to TPs in respect of training conducted prior to May 2017, the PRSG was informed that a committed liability of around Rs. 40 Cr. is estimated, as per details placed at *Annexure-IV*. PRSG was also informed that the estimated fund requirement for Course Fee and RCCF keeping in view the targets of FY 2018-19 would be around Rs.59.40 Cr., taking into account that only certification cost (80% of course fee) would be required as placement cost would not be required immediately. However keeping in view that only 4 months of FY 2018-19 are remaining, it is estimated that around 40% target of FY 2018-19 is estimated to be certified and the liability for these trainings would arise only in the first quarter of FY 2019-20. Hence a fund requirement of Rs. 23.76 Cr. (40% of Rs. 59.40 Cr.) is estimated for release in the first quarter of FY 2019-20 as per details at *Annexure-IV*. Thus, a total of Rs. 42.48 Cr. is sought for immediate release to NIELIT, which includes Rs. 2.48 Cr. towards PMU/MIS/Awareness/ Mobilization. Also Rs. 23.76 Cr. is sought for release in the first quarter of FY 2019-20.

Based on training targets, revision in fees, and committed liabilities, the breakup in demands for release of funds for Scheme-I and Scheme-II are at *Annexure-V*.

Recommendation: The PRSG noted the financial status and after deliberations recommended the demand for release of fund as above, the break-up of which is indicated at Annexure-V.

6.5 ESDM Portal & Resumption of Enrolments: The PRSG was apprised about the current status of the ESDM Portal (https://esdm-skill.deity.gov.in). It was informed that the existing ESDM Portal was initially designed as per the parameters defined under ESDM Scheme-1 and thereafter modifications were carried out to implement both Scheme-1 and Scheme-2. However, with amendments in administrative approvals and subsequent changes in the scheme parameters, the ESDM Portal has not been able to keep pace with the changing requirements and to incorporate necessary changes in the portal in line with the recent amendments, a ESDM Portal Committee comprising of officials from HRD Div., Meity, NIELIT and the ESDM-PMU has been constituted. Some amendments in the ESDM Portal are required to be incorporated urgently, as KIAs are expected to submit proposals for allocation of seats shortly. PRSG was also informed that suitable functionality within the ESDM Portal is also required for generation of invoices by the ESDM Training Partners through the Portal in line with the revised format for submission of Invoices as per Annexure-VI.

Recommendation: After deliberations, PRSG recommended that the ESDM Portal Committee may consider utilizing the funds available under the MIS sub-head for hiring the services of competent manpower so that the immediate modifications required in the portal can be carried out in-house. The manpower proposed be hired for the purpose by NIELIT should have the requisite qualification and experience to handle all portal related activities, including management of IT & infrastructure related issues. Till such time, services of requisite manpower is hired, PRSG was of the opinion that the ESDM Portal Committee/ NIELIT may consider utilizing internal resources to implement critical features in the portal. The PRSG further recommended that fresh enrollments may be resumed under both the Schemes with immediate effect.

- 7. Other Recommendations: Taking into account the deliberations that were held with regard to other key issues of the ESDM Schemes, the followings were also recommended by the PRSG:
 - SIAs under Scheme-1 may provide information regarding disbursement of payment to TPs on regular basis. Information may be shared on a monthly basis to KIAs as well as NIELIT-PMU.
 - For demand-based proposals, linkages with Placement agencies particularly in the case of LoI (Letter of Intent) may be considered subject to the proven credibility of the placement agency.
 - With a view to obliterate the gap between the batches for which Invoices have been received vis-à-vis the number of batches that have been certified till date, KIAs to ensure that all pending invoices are submitted to NIELIT-PMU latest by 15th January 2019, beyond which such Invoices may not be considered for reimbursement.
 - Under Scheme-1, the demand-based proposals would be submitted directly to SIA and SIA would further allocate to TPs based on the appropriate mechanisms.
 - All stakeholders to ensure that training parameters and invoices conform to scheme norms, guidelines & recommendations of Expert Committee/ PRSG as issued from time to time.
 - All stakeholders should make efforts for conversion of 'output' into 'outcomes'. SIAs/ KIAs to prepare success stories and case studies so that these can be showcased at appropriate forum.
 - PMU to make efforts to reach out and interact with stakeholders for greater promotion and awareness including conduct of workshops / seminars and meeting Training Partner meets at different States to assess ground realities.
- 8. The meeting ended with a vote of thanks to the Chair.
