- 2. Fixing of the switches in wall mount Racks.
- 3. Fixing the I/O and TR boxes.
- 4. Casing and Capping
- 5. Testing.
- 6. Provide comprehensive maintenance support services during warranty period for equipments supplied, commissioned and installed. This involves comprehensive maintenance and repair of supplied equipments including replacement of part(s) including spares, etc. to make the Network operational. This will include all kind of breakdown maintenance and preventive maintenance. The breakdown could be for any reason. The equipment supplied by you shall be under comprehensive on-site warranty for three years.

- 4. The bidder should be authorized supplier of the OEM. A documentary proof for the same must be attached along with the bid, otherwise the bid is liable to be rejected.
- 5. The quotation must be accompanied by an earnest money of Rs.5,000/- (Rupees Five Thousand only) in the form of demand draft in favour of NIELIT, AJMER payable at Kekri which will be returned to all the unsuccessful Vendors within 30 days from the date of issue of work order. This earnest money will be returned to the selected vendor on acceptance of the material supplied by the vendor.
