



### **OVERVIEW**

### **ABOUT NIELIT**

National Institute of Electronics and Information Technology (NIELIT), is an autonomous scientific society of Ministry of Electronics and Information Technology (MeitY), Government of India, and is actively engaged in skill development and development of human resources in the areas of IT; Electronics; Communications Technologies; Hardware; Cyber Law; Cyber Security; IPR; GIS; Cloud Computing; e-Governance and related verticals. NIELIT is also the preferred agency for many State Governments for rolling out IT Literacy programmes for its employees and the masses.

NIELIT undertakes various projects under Capacity Building in IECT with the objective of creating human resources at various levels, which includes employment and self-employment linked quality and cost effective training programmes. Besides, NIELIT also conducts IT Literacy programmes for the masses, especially targeted towards the rural/ underdeveloped areas in the country. It is also a professional examination body in India, which accredits training programs in IT and Electronics, specialising in the non-formal sector of education and training.

NIELIT is functioning under the overall control and guidance of the Governing Council. The Hon'ble Union Minister for Electronics and Information Technology is the Chairman of the Council while Hon'ble MoS(E&IT) is the Deputy Chairperson. Members of the Council are from various fields / organizations such as Government Departments, Industry, Academia and representatives of various professional bodies. The Institute also has a Management Board chaired by the Secretary, Ministry of Electronics and Information Technology (MeitY), Government of India. Each NIELIT Centre has an Executive Committee consisting of representatives from respective State Governments, academic institutions and industries

for the effective implementation of the decisions of the Board and the Council. The Finance & Accounts Committee chaired by the Director General, NIELIT assists the Governing Council by recommending the Budget Estimates / Revised Estimates and Financial Issues / Solutions of the Organisation. The Committee is also mandated to scrutinize the Audited Annual Accounts of the Institute before their submission to the Governing Council for adoption. The F&A Committee also advises the Institute from time to time in various financial matters and appointment of Auditors of the Institute. The day to day activities of NIELIT are managed by the Director General.

The vigilance activity in NIELIT is headed by a Chief Vigilance Officer (CVO), a senior officer from MeitY. The CVO is assisted by a Vigilance Officer at each Centre and also at NIELIT Headquarters. The vigilance activities of NIELIT include the preventive measures which are required to create a healthy and transparent working environment. In order to promote transparency and accountability, mandatory provisions of the Right to Information Act (RTI) have been implemented in the Institute with effect from July 2005. The Public Information Officer at Headquarters, as well as, the Public Information Officers at all the Centres of the Institute have been appointed. To deal with the requests under RTI Act, internal procedures have been formulated and the mandatory information has been hosted on the NIELIT website (www.nielit.gov.in). With a view to bring excellence in public service delivery and to redress grievances of citizens in a meaningful manner, NIELIT has also appointed a Public Grievance Officer (PGO), in line with the guidelines promulgated by Department of Administrative Reforms & Public Grievances. The statutory instructions for use of Hindi are being complied with in accordance with region wise locations of NIELIT Centres.

### CAPACITY BUILDING, SKILL DEVELOPMENT AND PROCESS RE-ENGINEERING

Skills development is crucial for stimulating a sustainable development process and can make a contribution to facilitate the transition from the informal to the formal economy. The principles and values of decent work provide guidance for the design and delivery of skills development and are an effective way of efficiently managing socially just transitions. The National Policy on Skill Development is aimed towards empowering all individuals through improved skills, knowledge and nationally and internationally recognized qualifications to gain access to decent employment and to ensure India's competitiveness in the global market. NIELIT plays an important role for skilling of youth in the area of IECT, especially in rural sectors. The wide repertoire of NIELIT Courses includes: (a) Courses in the Formal Sector offered by the NIELIT Centres in association with State Universities/Technical Board such as M.Tech, B.Tech, MCA, BCA programmes; Aurangabad Centre is also conducting PhD Program in the area of Electronics (b) Courses in the Non Formal Sector in IT, Hardware, Bio-informatics etc., under four levels, namely 'O' (Foundation); 'A' (Advance Diploma); 'B' (MCA equivalent); and 'C' Level; Short Term Courses in niche areas; and IT Literacy Programmes for the proliferation of Digital Literacy in the country; besides specialized programmes in e-Governance targeted towards empowering the employees of the State Governments. In addition, NIELIT has also created expertise for the roll out of customized skill development programmes, as per specific needs of public and private sector firms.

NIELIT has established itself as a premier organization having pan-India presence through a network of 35 own Centres at Ajmer(Kekri), Agartala, Aizwal, Aurangabad, Calicut, Chandigarh, Chennai, Delhi, Gangtok, Gorakhpur, Guwahati, Imphal, Itanagar, Kolkata, Kohima, Patna, Srinagar, Jammu, Ranchi, Shimla, Lucknow, Chuchuyimlang, Shillong, Jorhat, Silchar, Senapati, Tezpur, Lunglei, Leh, Churchandpur, Srikakulam, Ropar, Tezu, Kokrajhar, Pasighat with its Head quarters at New Delhi. It is also well networked throughout and a network of about 900+ accredited training institutions (O/A/B/C Level), besides a network of about 8000+ facilitation centres (CCC/BCC). NIELIT is making efforts to bridge the 'digital divide' through skill development leading to employability of youth, especially for the marginalized sections of the society. With the objective of using technology for process re-engineering, at NIELIT, many institutionalized mechanism has been put in place. To bring uniformity across various centre's websites, NIELIT has implemented common integrated website for HQ and all its Centres replacing multiple websites. In order to achieve uniformity in terms of course duration, syllabus, content, evaluation method etc. 65 short term courses were standardized. Student Web portal of NIELIT was suitably modified to facilitate the centralized online registration and has been rolled out from 01st March, 2016. A 24x7 accessible Expert Empanelment System for various activities of NIELIT (www.nielit.gov.in/ expert empanelment) has also been launched. Experts meeting minimum eligibility and conversant with the new/emerging technologies are allowed to apply and are being empanelled through a transparent process. A web application has been developed for all the employees of NIELIT H.Q. and NIELIT Centres enabling them to submit their Monthly Appraisal Forms online. The purpose of implementing this system is to motivate the employees for self evaluation of the work/duties assigned to them.

Model Career Centres (MCCs) under the National Career Service Scheme of the Directorate General of Employment have been setup at 6 NIELIT Centres at Calicut, Gorakhpur, Aurangabad, Srinagar, Imphal & Kolkata. MCC at NIELIT Leh Centre is going to start shortly. The MCCs at NIELIT Centres are organizing regular Job Fairs and providing counseling to the students of the region and thus facilitating the aspiring youth from rural and weaker sections of the society. At MCC Calicut alone about 8000 job seekers and 29 reputed private companies participated in the fair and 838 job seekers were selected for placement by various employers. NIELIT's placement portal has also started showing results. To further facilitate the NIELIT students in job placement, NIELIT has signed a non exclusive MoU with Monster.com. NIELIT Centres have also conducted training on NCS Portal for about 1000 Employment Exchange officers/officials. NIELIT J&K has conducted computer training

programmes for about 350 Indian Army personnel. In recognition of NIELIT's capabilities, many state governments are assigning the task of implementation of national projects to NIELIT. The NIELIT Centre at Srinagar/ Jammu has set up 'smart classrooms' in 423 government schools in the state of Jammu and Kashmir, which seeks to improve the quality of education through the proactive use of technology.

NIELIT has been mandated to undertake various projects under capacity building in ICT with the objective of creating human resources at various levels, including the development of employment and self-employment linked quality and cost-effective training programmes, besides conducting IT literacy programmes, especially targeted towards the rural/ underdeveloped areas in the country. NIELIT has a strong presence in the North Eastern Region of India and contributing in North-East region in the areas of Capacity Building and Skill Development in IECT. NIELIT has also participated in the "Destination North-East 2016" event organized by "Department of North-East Region(DONER)" in New Delhi. During the event a NIELIT brochure on "Empowering North-East India through Capacity Building and Skill Development in IECT" was also unveiled by Hon'ble MoS for Parliamentary Affiars(Independent Charge). The Brochure showcased the various Capacity Building and Skill Development prgrammes in the area of IECT which are being rolled out in all the 8 states of NE region.

### **DIGITAL INDIA**

The Government has embarked on the ambitious 'Digital India' program, which is based on three fundamental pillars – to create digital architecture as a utility for citizens of India; to ensure digital delivery of services; and to digitally empower the citizens of India. Digital empowerment refers to digital literacy and essentially means that people, who may not be literate, are trained to handle digital devices so as to take advantage of e-Governance and digital services and make a meaningful transformation in their livelihood. The digital revolution has begun in the country with NIELIT with its growing network of centres, including private training partners in the PPP framework, is suitably poised to take forward the National Digital Literacy Mission (also known as DISHA) that aims to bridge the digital divide. By minimizing the digital divide through skill development and by providing basic digital literacy at the click of a button, NIELIT aims for more industry courses for creating jobs for the youth, especially in rural areas.

Keeping pace with changing technology, NIELIT is making concerted efforts to take forward skill development and capacity building initiatives, specially in emerging areas such as IoT, e-Waste, Cloud Computing and Cyber Security etc. NIELIT has been awarded a project by MeitY for Capacity Building of Government Officials through training programmes in e-Waste Management under 'Digital India'. Under the project 4330 Central/State Government officials covering 29 states will be trained by NIELIT. In order to implement the project in an effective and professional manner, NIELIT has also signed MoU with MAIT(Manufacturer Association of Information Technology). NIELIT has also signed a non exclusive MoU with Amazon Internet Services Pvt.Ltd (AISPL). Under this MoU, AISPL will provide free access to more than 50 services like Database Services, e-Mail services, Virtual Private Connection services, Big Data services, Media services to NIELIT students and trainers/educators for achieving cloud education goals (as per Industrial standards and requirements) which enables students and trainers to get hands-on experience in creating Virtual Machines, installation of Application Software and their management in a live environment.

Under the 'Digital India' Programme of Govt. of India, NIELIT has signed an Agreement with National e-Governace Division (NeGD) to train 16000 Government employees of all the North-Eastern States in 2 years. This is a project of MeitY, Govt. of India under a special scheme "Preparing North-East for Digital India". Under this Programme 10000 nos. of Government officials will be trained in NIELIT's Digital Literacy Course CCC and 6000 officials will be trained in CCC+.



### **EMPOWERING 'RURAL INDIA'**

Inder Pradhaan Mantri Sansad Adarsh Gram Yojana(PM-SAGY) for developing model villages Shri Ravi Shankar Prasad, Hon'ble Minister E&IT and Law & Justice, Govt. of India has adopted Ahlawalpur village, Fatua block of Patna District, Bihar. NIELIT has set up a Computer Saksharta Kendra in Ahlawalpur vilage which was inaugurated by Shri Ravi Shankar Prasad on 18th May 2015. Since then NIELIT has been conducting various Skill Development Programs at the Computer Saksharta Kendra in order to digitally empower the local residence, especially adolescents, girls and women in the area. To provide a thrust to these initiatives, NIELIT Patna has collaborated with NIIT Foundation and Intel. As a part of this collaboration, a skill development programme "Intel Easy Steps" was conducted for skilling 200 local residents of Ahlawalpur comprising of above, 150 females and 50 male residents.

### e-GOVERNANCE

NIELIT is issuing digitally signed certificate to the NDLM candidates in the Online mode, which bears a QR code, so that the online certificates can also be verified in the Online mode. Digital Certificates are also linked with Digital Locker and so far more than 766738 certificates have been uploaded at the DigiLocker portal. NIELIT has digitized all its files/records and has also started moving files through *e-Office*. The digitized files are being migrated to *e-Office*. Further, to cater to the skill development needs of this new paradigm, NIELIT has developed and initiated e-Governance training programs focusing on the use of information technology to bring public services to the doorsteps of our citizens.

# SUPPORTING 'MAKE-IN-INDIA' THROUGH CAPACITY BUILDING AND SKILL DEVELOPMENT IN ELECTRONIC SYSTEM DESIGN AND MANUFACTURING (ESDM)

The schemes for skill development in ESDM Sector launched by MeitY have gained momentum in all the states/UTs of the country. During this financial year about 60000 enrollments have been achieved. Presently there is a large gap in demand and supply of skilled workforce for Electronics Manufacturing industries and therefore, the scheme focuses on students/unemployed youth at 8th standard onwards, ITI, Diploma, Non Engineering graduates etc. To increase their employability in manufacturing and service support functions. These schemes of skill development are covering all states/UTs to create an echo system for development of ESDM Sector in the entire country for facilitating skill development for 418000 persons over a period of 4 years. The schemes also provide for 100% financial assistance to SC/ST/EWS candidates and 75% financial assistance to general category of candidates.

A basket of 80 courses (49 courses in service sector and 31 courses in manufacturing sector) has been included in these schemes jointly by Electronic Sector Skill Council of India(ESSCI), Telecom Sector Skill Council(TSSC) and National Institute of Electronics & IT(NIELIT). Most of the courses being offered are NSQF compliant between Level 1 (11) and Level 5 (15).








### **INCOME V/s EXPENDITURE OTHER THAN NPR**




### **INCOME V/s EXPENDITURE WITH NPR**










# ACTIVITY WISE REVENUE GENERATION OF NIELIT FOR THE YEAR 2015-16 (OTHER THAN NPR)

### **SCHEDULE 24:**

#### SIGNIFICANT ACCOUNTING POLICIES

The NIELIT, an Autonomous Scientific Society (renamed with effect from 10.10.2011 from DOEACC Society) under the administrative control of Ministry of Electronics and Information Technology (MoEIT), Government of India was set up during November, 1994 to carry out Human Resource Development and related activities in the area of Information & Communications Technology (ICT). The society is registered with Income Tax Department u/s 12A and has been formed exclusively for the purpose to generate quality manpower and develop skilled professionals in the area of Information, Electronics & Communications Technology (IECT) and allied fields, by providing world class education & training and accreditation services. The Society is engaged both in the formal & Non formal Education in the area of Information & Communications Technology (ICT) besides development of Industry oriented quality education and training in the state-of-art areas establish standards to be the Country's premier Institution for Examination and Certification in the field of ICT. It is also a National Examination Body which accredits institutes/organizations for conducting courses particularly in the Non formal Sector of IT Education & training. NIELIT is working through its 19 centres- Aizwal, Aurangabad, Agartala, Ajmer, Calicut, Chandigarh, Chennai, Delhi, Gangtok, Gorakhpur, Guwahati Itanagar, Imphal, Kolkata, Kohima, Patna, Ranchi, Shillong, Srinagar & Jammu.

#### 1. ACCOUNTING CONVENTION:

#### A) Method of Accounting

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated on the accrual method of accounting.

#### B) Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of financial statements and the reported amount of revenues of expenses during the reporting period. Difference between the actual results and estimates are recognized in the period in which the results are known/ materialize

#### 2. INCOME RECOGNITION

All the NIELIT Centres are following accrual method of accounting except:

 Kolkata and Ranchi Centers which are recognizing the fees from SC/ST students at the time of reimbursement of Grant.

- Chennai centre is following cash basis accounting for accreditation fees, Variable accreditation Fees and Awareness Creation Fund.
- Agartala Centre is following cash basis in respect of fees related to SCSP & TSP scheme and Income related to E-Vidya project.

#### The Grant-in-Aid released by the DeitY for setting-up of New Centers for meeting of Recurring Expenditure has been accounted for, as detailed below:-

#### 4. Investments

Funds of the Society invested in Short Term Fixed Deposits with nationalized banks have been shown as per guidelines of the Society for "Treasury Management of Surplus".

Interest on Fixed Deposit kept for Earmarked/ Endowment Fund received during the year, is being credited to respective Earmarked/ Endowment Fund.

#### 5. Fixed Assets

Fixed Assets are stated at cost less accumulated depreciation. Cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses related to acquisition. In respect of project involving construction, related pre- operational expenses, form part of the value of the Assets capitalized.

- In respect of Calicut Centre, the value of equipments consisting of 137 numbers of items given as grant to the Centre by UNDP have been shown at a notional value of Rs.1/- on both liability and asset side.
- In respect of Kolkata Centre, the "Leasehold Land" at Sector-1 of Bidhannagar (Salt Lake, Plot no. 267, Block-BF) has been shown under the head "Building" in the Fixed Assets schedule.



### **SCHEDULE 24:**

#### SIGNIFICANT ACCOUNTING POLICIES

- In respect of Agartala Centre, 15 Acres of Land for building the permanent campus has been allotted by Govt. of Tripura at free of cost, the same has been shown at the Nominal Value of Re. 1/-.
- In respect of Agartala Centre, Building for the initial training facility of the Centre has been allotted by the Govt. of Tripura. All expenses relating to civil repairing, alteration electrical works and other miscellaneous expenses relating thereto has been shown as deferred expenditure to be written off over the period of occupancy and being amortized @ 20% w.e.f. Financial Year 2011-12 since the building is not owned by the NIELIT, expenditure have been shown as deferred expenses.
- In respect of Chandigarh , there was a major fire incident took place in the building occupied by NIELIT at SCO 114-116, sector 17B, Chandigarh. The assets amounting to (original cost) Rs 7,20,31,215 were lost in fire and the same have been written off in the books after getting approval of competent authority. Insurance claim for the lost assets have also been settled and accordingly requisite entries have been accounted for.
- In respect of Guwahati Centre, the land allotted by the Govt. of Assam for construction of the permanent campus at free of cost at Guwahati Main (3 acres), Kokrajhar Ext. Centre (6 Acres), Jorhat Ext. Centre (3 Acres), Dibrugarh Ext. Centre (3.3 Acres) and Tezpur Ext. Centre (6.62 Acres) has been shown at nominal value of Rs.1 in each case.
- In respect of NE Capacity Building Project of Silchar & Jorhat Extension Centre, expenditure incurred on renovation of building (Civil & Electricals) taken on rental basis for a period of 4 years has been shown as deferred expenditure to be written off over the period of occupancy. Further, in respect of NIELIT Guwahati (City Centre), expenditure incurred on renovation incurred on renovation of building (Civil & Electricals) taken on rental basis for a period of 10 years has been shown as deferred expenditure to be written off over the period of occupancy.
- The Government of Rajasthan has allotted 16.33
  Hectares of land at Village Khoda near Kekri Distt.
  Ajmer for 99 years lease at free of cost has been
  shown at the nominal value of Re.1/-.
- Land measuring about 10 acres has been transferred to NIELIT Shillong by Government of Meghalaya as

- free of cost for a normal term of lease which is for 30 years for the purpose of setting up of permanent campus of NIELIT Shillong.
- The additional space measuring 5818 Sq Ft. of built up area hired from Meghalaya State Housing Finance Co operative Society (MSHFCS) limited for 4 years for office and for conducting training activities. All expenses relating civil repairing, alteration, electrical works and other miscellaneous expenses relating thereto have been shown as deferred expenditure to be written off over the period of occupancy.
- A temporary space of 8000 sq ft. area, on 11th floor of Biscomaun Tower, Patna was allotted to NIELIT Patna Centre by the state Government of Bihar via letter No. 9654/13 dated 23/12/2013. On the sais temporary space, civil & electrical renovation work and interior furnishing work was awarded to M/s NBCC for which an estimated cost of Rs 49.99 lakh and Rs 42.09 lakh respectively was submitted by them. After completion of a portion of the said work, M/s NBCC has stopped working. The remaining work was completed by management of NIELIT Patna Centre at its own cost.

The above mentioned Cost has been capitalized in the books of accounts in the below mentioned heads as follows:

Renovation of Building - Rs 41,23,393 Furniture & Fixture - Rs 19,43,325 Electrical Installation - Rs 26,97,043

- No. of Adobe perpetual license were allotted to Kolkata Centre, However payment for the same was made by head quarter. Accordingly value of License has been booked at nominal value of Rs. 1/- under Fixed Assets.
- In respect of Aurangabad Centre, 10 software licenses pertaining to Adobe master collection capitalized as fixed assets at Re 1/- and corresponding amount of Re 1/- added to Capital reserve account.
- Calicut, Perpetual licenses of Adobe Master Collection (5 Nos) received has been booked at a nominal value of Re 1/- as per HQ Letter No. NIELIT/HQ/ADT/16/2015 dated 7 July 2015.
- GHT- 10 Nos of Adobe perpetual license were allotted to Guwahati Centre and payment by HQ vide letter No. NIELIT/HQ/ADT/16/2015/352 dated 07.07.2015 and directed to show nominal value of Rs 1/- under Fixed Aseets.



## **SCHEDULE 24:**

#### SIGNIFICANT ACCOUNTING POLICIES

- In respect of NIELIT, Aurangabad Centre, payment of Rs.75.00 lakh was made to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad in the year 2013-14 as per MOU for construction of Girls hostel in University campus. The rights of ownership are vested with the University and taking into consideration initial validity of MOU for 5 years, in the circumstances expenditure is treated as "Deferred Revenue Expenditure" and same to be written off over a period of 5 years accordingly Rs.15.00 lakh is appropriated as expenditure for the financial year 2015-16.
- Shillong -Assets namely, Land -Leasehold, Office & Other Equipments and software which have been transferred to NIELIT Shillong as free of cost are taken into account with a Nominal Value at Rs 1/- per item as per AS-15.

#### 6. **Depreciation**

a. Depreciation for current year on "Grant related Assets" is debited to Income & Expenditure Account and also credited to Income & Expenditure Account as per AS-12 and deducted from "Capital Grant-in-Aid" during the year.

Depreciation is provided on W.D.V. method as per rates specified in the Income Tax Act 1961.

#### 7. Government Grants

The Grant-in-Aid (Plan) of Rs. 500.00 lakhs for the year 2015-16 has been accounted for on actual receipt basis. Capital Grants are credited to Capital Fund of the respective Centre.

The Grant-in-Aid released by the DietY for setting up of New Centres for meeting of Expenditure(Capital/Recurring) has been accounted for, as detailed below:-

The Grant-in-Aid (Non Plan) of Rs. 526.00 lakhs for the year 2015-16 has been credited to Income and Expenditure Account in the respective Centre Account.

Capital Grants-in-Aid are shown as net of depreciation on the fixed Assets procured out of such Grant.

#### 8. Change in Accounting Policy

The Gorakhpur Centre, which was earlier following Cash/realization basis of accounting for fees of SC/ST students at the time of reimbursement of Grant, has changed its Accounting on Accrual basis and made a provision of Rs. 17,92,474/- during the year towards the fees reimbursement receivable under SCST/TSP Scheme. This has resulted in increase of the revenue by the sum of Rs. 17,92,474/- during the Current Year.

#### 9. **Employee's Benefits**

Provision for Gratuity is accounted for on actuarial valuation as per AS -15. The liability of Gratuity in respect of Calicut, Chandigarh and has been covered by the policy obtained in favor of the respective Employee's Trust under Group Gratuity cash accumulation from LIC of India. NIELIT employees are covered under the existing Gratuity scheme as on 14.12.2002 i.e. on month emoluments (Pay + Grade Pay) for each employee, for each completed year of Service.

Provision of Leave Encashment is accounted for on actuarial valuation basis as per AS-15.

NIELIT HQ and Centres have been covered under EPF w.e.f. 01.01.2003 with the approval of the Competent Authority. EPF Contributions from April, 2013 onwards are being deposited with RPFC. The arrears of EPF for the period from 01.01.2003 to 31.03.2013 has been deposited with EPF Office. The balance lying in NIELIT CPF is being reconciled.

#### 1. Contingent Liability:

#### Aurangabad Centre

M/s DVIIT, Aurangabad has filed RCS 495/1999 and SCS 168/2002 before Hon'ble CJSD, Aurangabad against Government of India (DIT through its secretary, New Delhi) as First Party and CEDTI Aurangabad (Presently NIELIT, Aurangabad) through its Director as Second Party and claiming the rendition of Accounts and recovery of Rs. 72.00 Lacs towards its 40% share & interest thereon. The Hon'ble court has passed the order on 5th December, 2011 in both the suits dismissing the claim of the plaintiff with cost.

Thereafter the plaintiff has filed appeal No. 559/2012 (Related to 495/1999) the hearing of which is pending. Also plentiff has submitted an appeal bearing No. 1170/2012 in the Hon'ble High Court of judicature of Bombay, Bench at Aurangabad and presently the matter is pending at Hon'ble High Court.

Centre had erroneously deposited Service Tax of Rs 74.86 lacs with the Service Tax Department against the bills raised to Department of Higher Education (DHE), Govt of HP, Shimla for the period from March 2013 to January 2014. However, the Service Tax was not applicable during the period. Accordingly, an amount of Rs 74.86 lacs is recoverable from the Service Tax Department and payable to DHE Shimla who have already disputed payment of aforesaid service tax to NIELIT. Refund claim for the same was filed on 11.03.2014 with the Service Tax Department which is yet to be settled.

Amount of Rs. 2,68,650/- claimed by KVS regarding disputed over-payment made by them to the Centre (Formerly RCC) for providing instructors for school project. The matter is still pending.

ESI had issued demand notice for Rs. 11,22,702/- and 303,947/- for ESI scheme which has been got stayed. The Civil Judge (Sr. Division), ESI Court Chandigarh vide order dated 07.12.2010 had set aside the order of ESI for recovery. But the Dy. Director, ESI vide his Order NO. PB 17000399790001013/245 dated 21.07.2011, has again directed this Centre to pay the amount. The centre has filed writ petition with Hon'ble Punjab & Haryana High Court. Hon'ble High Court has stayed the recovery. The matter is still pending.

#### Kolkata Centre

RCC Employees Contributory Provident Fund Trust with Income Tax recognition is maintaining PF of employees who have joined NIELIT before 01.01.2004. However, PF of employees who have joined on or after 01.01.2004 is maintained at NIELIT Headquarter under CPF Act 1925. The Centre has received a notice on 11.07.2006 and order u/s.7A dated 09.07.2008 and u/s 7B dated 30.01.2009 from Regional EPF authority that NIELIT will be covered under EPF & MP Act. 1952 from August 1982. Against the above mentioned orders the Centre has filed an appeal to the EPF Appellate Tribunal, Delhi (appropriate authority) that our Head quarter is covered under CPF Act, 1925, as per GOI Gazette Notification dated 26.07.1997. However, the EPF Appellate Tribunal, Delhi has dismissed the appeal by order dated 03rd August, 2011. The Centre has there after filled an appeal with the Honorable High Court, Kolkata against the aforesaid order, on 21st March, 2012. The said appeal is still pending.

The Centre has paid a sum of Rs.1,56,854/- under protest against demand of Rs.6,27,413/- from Employees State Insurance Corporation West Bengal Region. The demand has been disputed by the Centre.

There is a contingent liability of Rs 19,67,385/regarding service tax as per show cause notice dated 21/10/13 received from Additional Commissioner of Service Tax which has been disputed by the centre vide letter dated 21/04/14.

#### 2. Capital Commitment

- In case of Kolkata Centre there is capital commitment of Salt Lake Building amounting to Rs. 1267.94 Lacs (Previous Year Rs. 44.95 Lacs). Advance given to CPWD is Rs 870.02 Lacs upto 31.03.2016 (Previous year Rs 645.02 Lacs)
- In case of Head Quarter, Office space at NBCC Tower, kidwai nagar is being purchased for Rs. 48.36 crores out of which Rs. 16.44 crores has been paid till 31st March, 2016.

During the year 2015-16, the following Centres have made provisions of Rs. 6.50 crore, out of surplus for the year 2015-16 for meeting the cost of office space for NIELIT Delhi Centre as decision taken in the Governing Council in its 32nd Meeting held on 29th November, 2014.

Against this , NIELIT (HQ) and Gorakhpur Centre have also invested the funds in Bank FDRs.

 In case of Head Quarter, building is building is constructed at Dwarka, Delhi. Total Estimated Cost is Rs. 42.90 Crores out of which Rs. 16.93 Crores has been paid till 31st March, 2016

#### 3. Current Assets, Loans and Advances

In the opinion of the management, the current assets, loans and advances have been stated at the value which will be realizable in the ordinary course of business, except in the case of debtors where provision for Bad & doubtful debts provided for.

#### In Case of Delhi Centre

A provision of Rs. 2,16,542/- only for doubtful debt has been made in respect of sundry debtors amounting to Rs 54,88,871/- (Apart from (ii) & (iii) stated below) which are outstanding for more than three years. (I.e. before 31.03.2013), which in the opinion of the management is reasonable.

A provision of Rs. 28,11,468/- only has been made towards doubtful debts against recoverable of Rs. 1,12,71,327/- from Director of Education, Jhandewalan. This amount is due since 2004-05. The matter is under arbitration. in the opinion of the management quantum of provision made is reasonable.



#### 4. **National Population Register (NPR)**

- Department of Electronics, Information & Technology a) vide its letter bearing No: FNo7(2)2011-EG-1 dated 05/04/2011 has entrusted the work of Demographic Data Digitization & Bio-metric data collection for creating National Population Register(NPR) in respect of 17 States & 2 Union Territories . RGI vide its DO No;9/83/2010-CRD(NPR) dated 27.06.2012 has withdrawn the work of Bio-Metric data digitization from NIELIT.
- b) Office of the Registrar General of India had released an advance of Rs 522.24 crore to the NIELIT for execution of National Population Register Project. Total liability towards Data Digitization (NPR Project) as assessed/ estimated by the management stands at approximately Rs.571 crore. As per payments terms of RFQ, balance 30% payment to MSP's has not been released. As on 31.03.2015, an amount of Rs. 245.91 crore has already been utilized. The balance amount of Rs. 474.71 crore is available (including interest) in various bank Accounts (Saving/Current) and in the form of Deposits. The work of Data digitization has been completed. The last Digitized Data has been handed over to RGI during October.2013.
- Separate Books of Accounts have been maintained c) by all the NPR participating NIELIT Centres w.e.f 01.04.2012 in respect of NPR project & prepared separate Annual Account from the F.Y. 2012-13.
- d) Interest amounting to Rs 179.36 Crore Earned/ Accrued on unutilized Advance has been earmarked under Liabilities and not accounted for as Interest Income in the absence of guidelines from RGI.
- M/S CSC-SPV has been paid an advance of Rs 29.29 e) Crore for monitoring and supervising the work of data digitization in rural zones. M/S CSC-SPV has incurred an expenditure of Rs. 29.29 Crore upto 31.03.2016 towards cost of monitoring and supervising the work of data digitization in rural Zones. Provision amounting to Rs 29.70 Crore has been made in NPR books at HQ, subject to approval of expenditure by Competent Authorities. Duly approved actual expenditure incurred by M/S CSC-SPV will be accounted for in the books of NPR Participating centres.
- f) Major fire broke out during June 2014 in the office building of NIELIT Centre Chandigarh, due to which all infrastructures and Centre records have been

- destroyed. NPR assets amounting to Rs 33,97,366/-(Net Block Rs. 8,37,687/-) was lost in the fire. During financial year 2015-16, NIELIT Centre Chandigarh has received claim of Rs. 7,09,149/- from Insurance company and accordingly adjustment carried out in the books of accounts.
- As per terms of the RFQ, there was a clause charging g) penalty of even more than 100% of the invoice amount of the MSP's in case of non adherence of compliance of any terms of the RFQ. Since there has been delay in completion of data digitization work, some of the parties have not raised the bills. In the absence of bills raised by the parties for the services rendered by them, liability/ penalty thereof can not be ascertained. The same will be accounted for in the year in which the bills are received.
- 5. As per information available, we here by confirm that the society is not having any amount payable to any party covered under Micro Small & Medium Enterprises as defined in section 7(1) of the Micro Small & Medium Enterprises Development Act, 2006, and the auditor has relied upon the same.
- 6. Society is not collecting Service Tax on Accreditation Services provided by HQ and the same has been confirmed by an expert opinion.
- 7. A sum of Rs. 43,24,045/- deposited with Municipal Corporation, Chandigarh, for the allotment of land to the centre has been shown as recoverable, This amount has been forfeited by the said corporation as the land has been surrendered by the centre, The Chandigarh Centre filed writ petition with the Hon'ble Punjab and Haryana High Court, Chandigarh, for obtaining sufficient financial relief for getting refund which has been dismissed. The Centre is in the process of moving an application before the Hon'ble Court for the restoration of the case.
- 8. Previous year figures have been regrouped or rearranged wherever necessary.
- The figures have been rounded off to the nearest Rupees. 9.
- Debtors & Creditors are stated in the books at the 10. value which is recoverable/payable. However, the confirmation from the parties is under process.
- 11. During consolidation of various centres, heading/ groups has been re-arranged for better and fair presentation.
