The sealed quotations should be submitted in sealed covers.

The last date and time for submission of sealed quotation by 05.00PM on 15.04.2021 and the same will be opened on at 03.00PM on 16.04.2021. The quotations submitted after the due date and time shall be rejected.

The bid shall remain valid for 60 days after the date of bid opening.

Items as per Annexure available at NIELIT Chennai Centre will be disposed off in one lot to the successful bidder and no part quoting will be entertained. Only single bid should be quoted for all the items and no separate bids should be given.

Bidders shall be empanelled/registered Recyclers/pre-processors/Registered PRO/EPR-authorized producers with Central Pollution Control Board/ State Pollution Control Board. Enclose proof as supporting document.

Bidder shall ensure that all e-waste manual dismantling and disposal operation as per the e-waste (management and Handling Rule 2011) and as per CPCB's final guidelines for implementation of the E-Waste (Management) Rules 2016 and applicable amendments.

The e-Waste offered for disposal is on "As-is-Where-Is" basis, available at NIELIT Chennai in unpacked condition.

The Quoting firms may visit NIELIT Chennai for inspect the Electronic/Electrical items, if required to satisfy themselves about the items they bidding for, as the items conditions is on "As-is-where-is" basis. No disputes regarding the form, nature, quantity or quality of equipment's shall be entertained.

The interested may inspect the materials at NIELIT Chennai on working days (Monday to Friday) between 10.00AM to 05.00PM.

The successful bidder has to make payment of full amount through on-line mode only, failing which the offer stands cancelled and withdrawn.

Taxes and duties that may be levied by the Government will be extra as applicable and shall be borne and deposited by the successful bidder before lifting of materials. GST as applicable will have to be deposited by the bidder over and above the bid amount before lifting the materials.

All bidders shall enclose GST registration certificate along with the quotation.
