### **Scope of Work**

The successful vendor will be required to:

1. Supply, install and configure the supplied hardware and software to create server and application virtualization environment.
2. Integrate the existing hardware i.e. Thin clients, desktops and laptops (total about 50 no.) with the above virtualized environment over the existing Local Area Network for accessing various application softwares and enable sharing other resources like printer.
3. Develop a process for addition/deletion of an application/server to the virtualized environment.
4. Provide basic training to the officials of NIELIT, Ajmer on the operation and management of equipments installed and commissioned by them covering Installation procedures, Configuring & fine tuning, System administration, User Management and Operations & Monitoring. However, the NIELIT, Ajmer and the vendor would mutually decide the period of training.
5. Provide comprehensive maintenance support services during warranty period for equipments supplied, commissioned and installed by it. The computer hardware supplied by vendor shall be under comprehensive on-site warranty for three years.

**TERMS AND CONDITIONS FOR SUPPLY OF HARDWARE AND SOFTWARE ITEMS**

The Vendor will be required to send **TWO SEPARATE ENVELOPES, FIRST ENVELOPE CONTAINING DEPOSIT OF EARNEST MONEY, QUALIFICATION BID (ANNEXURE A), TECHNICAL BID (ANNEXURE B), TECHNICAL LITERATURE AND TERMS & CONDITIONS WHEREAS THE SECOND CONTAINING THE FINANCIAL BID (ANNEXURE C) SHOWING RATES.** Pre-Bid meeting shall be held at office premises of NIELIT Ajmer on 10<sup>th</sup> Oct., 2013 at 12.00 PM. Qualification and Technical Bids will be opened at 2.30 p.m. on the same day of last date of receiving bids. **The Financial bids of the short-listed vendors will be opened on 17<sup>th</sup> Oct 2013 at 11.00 AM in the presence of the vendors or their representatives who wish to be present.** While opening the quotations, the envelopes containing Qualification Bid, Technical Bid and Terms & Condition shall be opened first and acceptance of the quotation according to the specified clauses will be ascertained. Financial Bid of only those bidders will be opened who qualify the eligibility criteria on the basis of Qualification and Technical Bid. 1. Bidder have to deposit earnest money of Rs. 30,000/- (Thirty thousands only) in the form of demand draft/FDR in favour of NIELIT, Ajmer payable at Kekri which will be returned to all except the successful vendor(s) selected for supply immediately after the order is placed. This amount will be returned to the successful bidder(s) on acceptance of the material supplied by them. In case the tenderer(s) fails to complete the supply according to the terms of the order, the amount of EMD will be forfeited.

**No Tender without Earnest Money Deposit will be entertained.**

2. **Prices quoted should be F.O.R. sites (quantity to be defined at the time of placing the supply order) inclusive of all charges like sales Tax/VAT, excise duty, insurance, technical service/installation charges, charges for Three years comprehensive warranty for Computer systems. Octroi as per actual shall be payable extra. No other charges/taxes/levies shall be payable. Form ‘C’/ ‘D’ will not be provided by NIELIT, Ajmer.**

3. Hardware and Software must be delivered within 6 weeks from the date of issue of the purchase order. Penalty for late delivery would be leviable at the rate of 0.5% per week subject to a maximum of 10 percent of the value of such portion of material as has not been supplied within the stipulated period. In case delivery is not completed within 2 weeks after the specified delivery period, NIELIT may cancel the order and arrange to procure the said items from any other source at the risk and cost of the vendor(s) and EMD will be forfeited.

4. **ELIGIBILITY CRITERIA**

The vendor fulfilling the following criteria will be eligible to qualify for opening of his Financial Bid (**by furnishing the information showing proof for all the criteria listed below**) :

- i. Vendor should be in business of IT hardware and software at least for the last 3 years.
- ii. The vendor should have executed at least one single order of commissioning Server-thin clients solution in a Virtualized environment.
- iii. The vendor should have valid authorization from OEM to supply the material.
- iv. Average Annual turnover should be Rs. 1.00 cr. for the last 3 years
- v. Should have adequate number of trained engineers (minimum Diploma in Computer Science/IT/Electronics) to provide maintenance support services. Details to be provided.
- vi. Should have valid PAN and Sales Tax Registration number.
- vii. Should not have been black-listed by and State/Central Govt. Organization.

5. **PAYMENT TERMS**

The terms of payment will be as follows:

- i. No advance payment against purchase order will be made.
- ii. 90% of the bill amount will be paid within 30 days of submission of the bill along with reports showing successful delivery, Installation & satisfactory functioning of Computer Hardware, Software.
- iii. Balance 10% of the value of the bill amount will be paid, against Pay Order/FDR/Bank Guaranty in favour of NIELIT Ajmer towards performance security of equivalent amount, with in 30 days after submission of Performance Security through any of the aforesaid instruments the satisfactory functioning report signed by the designated officer of NIELIT, Ajmer Centre. The Pay Order/FDR/BG should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.

6. Director, NIELIT, Ajmer, reserves the right to reject any or all quotation(s) without assigning any reason.
7. Sealed quotations, complete in all respects, should reach NIELIT, Ajmer, “Jain Palace, Sapnda Road, Kekri-305404” latest by **12:00 p.m. on 15<sup>th</sup> Oct., 2013**. Incomplete quotations or those without earnest money may be rejected. Technical bids & Financial Bids will be opened on the same day at 2.30 p.m. at **NIELIT, Ajmer at Kekri** in the presence of the Vendors or their representative who may wish to be present at the time of opening of the Technical Bids and Financial Bids. Financial Bids will be opened after evaluating the Technical bids.
8. Director, NIELIT, Ajmer reserves the right to revise or alter the requirements and/or specifications of the material before acceptance of any quotation and call for offers.
9. Director, NIELIT, Ajmer reserves the right to increase or decrease the quantity of the items in the purchase order.
10. Supply complete in all respect will be accepted in one lot at the NIELIT, Ajmer camp office address.
11. Users at site will conduct the acceptance test(s) on the system(s) ordered. If the system(s) supplied fail in the test(s), the same may be rejected. Replacement of cards or devices found faulty during such test may not be allowed and the vendor will have to supply new machine in replacement within a weeks’ times.
12. The acceptance test will consist of running the Systems for 6 hours daily for full seven working days.
13. Vendor will be required to provide license in the name of NIELIT, Ajmer for all software which will be installed, configured and used with the Hardware to carry out various functions. Vendor(s) should enclose printed brochure of the products quoted along with the technical bid.
14. Vendor(s) will be responsible for comprehensive maintenance of Computer systems for three years, free of charge, during warranty period after the acceptance of supplied material. In case of default, this Centre will have the right to arrange maintenance at Vendor’s risk and cost from any other source.
15. **Comprehensive maintenance will cover replacement of all defective parts/equipments, excluding nothing.**
16. **Vendor(s) should have satisfactory arrangement to receive complaints and provide maintenance on-site. The response time for attending to faults will be twenty four hours after these are reported to the Vendor. The Vendor will rectify the faults within 72 hours from the time of reporting, failing which Vendor will arrange standby equipment. In case, the Vendor fails to meet this requirement, NIELIT**

**Centre will have the right to arrange repairs/replacements at the costs and risk of the Vendor.**

17. The Vendor(s) must specifically mention the place, contact address, mobile number from where support for maintenance would be offered.
18. If a dispute arises out of or in connection with the contract, or in respect of any defined legal relationship associated therewith or derived there from, the parties agree to submit that dispute to arbitration under the ICADR Arbitration Rules, 1996. The Authority to appoint the arbitrator(s) shall be the International Centre for Alternative Dispute Resolution. The International Centre for Alternative Dispute Resolution will provide administrative services in accordance with the ICADR Arbitration Rules, 1996. The place of arbitration proceedings shall be New Delhi
19. In all matters and disputes arising hereunder, the appropriate Courts at Kekri/Ajmer alone shall have jurisdiction to entertain and try them.
20. Non-compliance of the above terms and conditions will render the tender liable for rejection.
21. **Copy of these terms and conditions duly signed and stamped on each page must be attached with the technical bid as acceptance of the above terms and conditions.**
22. **Bid Validity** – Bids shall remain valid for minimum Ninety (**90**) days from the date of opening of Financial Bid. A bid valid for a shorter period shall not be considered.
23. **Evaluation Criteria**

The following evaluation criteria shall be followed for selecting the vendor:

- i) Qualification bids will be opened and evaluated first as per the Eligibility Criteria.
  - ii) Technical bids of vendors meeting the Eligibility Criteria will be opened and evaluated as per the Technical specifications required.
  - iii) Financial bids of only those vendors will be opened and evaluated who are technically qualified.
  - iv) Vendor will be selected for supply of material on the basis of lowest quote for both hardware and software combined.
