And

National Institute of Electronics and Information Technology Aurangabad, (hereinafter referred to as the 'NIELIT Aurangabad') located at Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, Maharashtra which is one of the prominent Centers of National Institute of Electronics and Information Technology (NIELIT) an Autonomous Scientific Society under the administrative control of Ministry of

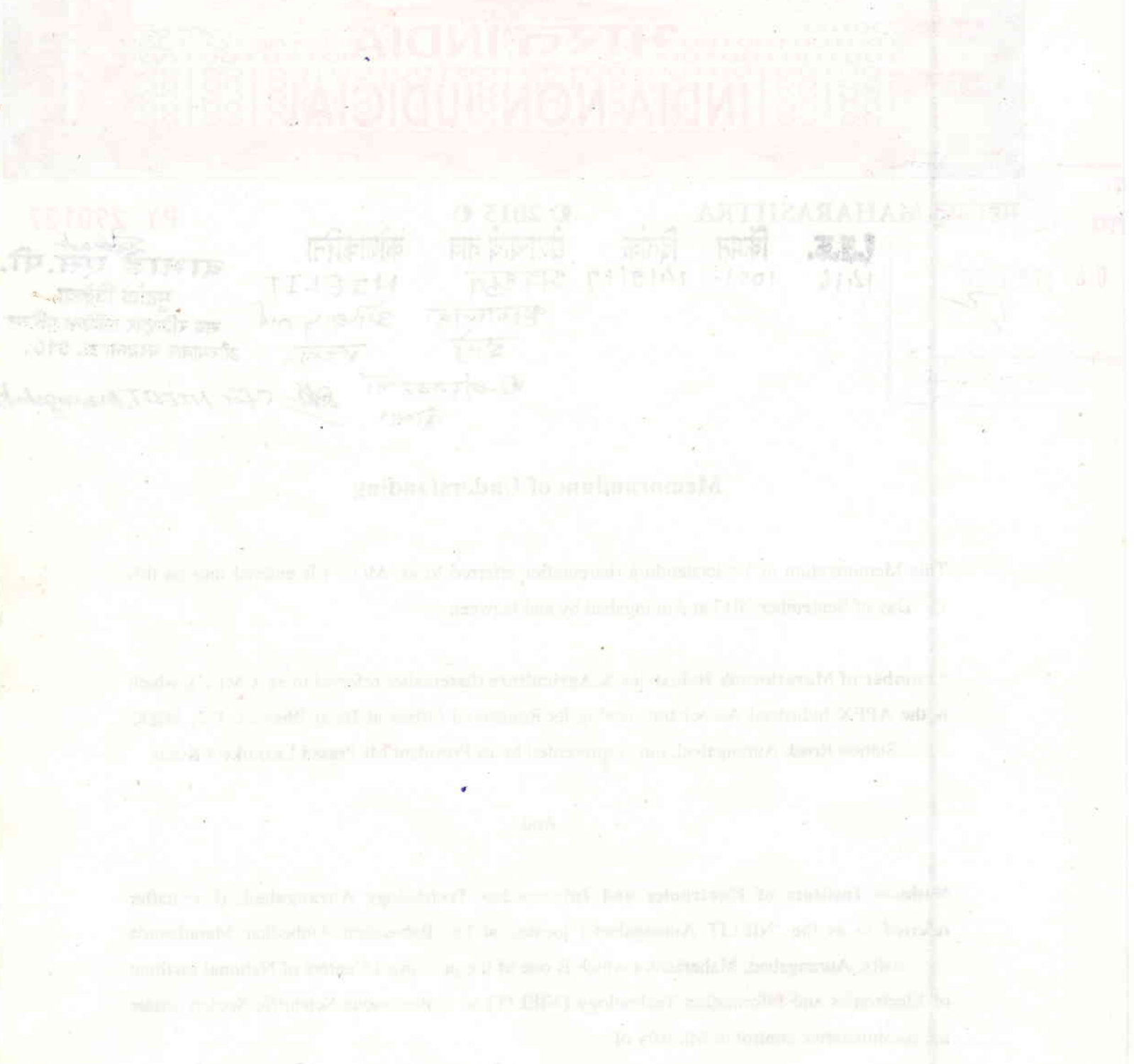

WHEREAS

A. CMIA is an APEX Industrial Association representing small, medium & large scale industries of Marathwada region.

B. CMIA has applied for registration under Atal Innovation Mission program of the National Institution for Transforming India (NITI Aayog) of the Government of Maharashtra for setting up Atal Incubation Centre at Aurangabad, Maharashtra.

C. In this regard, CMIA has already started procedure for incorporation of a Special Purpose Vehicle (SPV) as a Section 8 Company in the name and style of **Marathwada Accelerator for Growth and Incubation Centre** (hereinafter referred to as 'MAGIC') as per the criterion set out by the NITI Aayog.

D. CMIA is looking for Academic Support and NIELIT AURANGABAD is willing to extend the same to CMIA for the operation of the MAGIC.

E. NIELIT Aurangabad (erstwhile CEDTI), is engaged in skilling, product designing & development, applied research and consultancy in the field of Information, Electronics, Communication Technology (IECT).

F. NIELIT Aurangabad is also a Research Centre of the Dr. B.A.M. University, Aurangabad for conducting research leading to award of Ph.D. Degree in Engineering and Technology. It is offering capacity building courses especially in Electronics Design and Technology, Electronics product design and Development, Manufacturing (Electronics & Mechanical) Technology, Applied research and consultancy in both formal and non-formal sectors.

G. NIELIT Aurangabad, offers AICTE approved B. Tech. (Electronics System Engineering) and M. Tech. (Electronics Design and Technology) Courses that are unique Engineering and Technology courses offered in the country that are designed with the belief that any engineer concerned with the development of new

electronic product needs to integrate the functional design, industrial design, equipment packaging and manufacturing.

H.NIELIT Aurangabad also organizes faculty Development programs and skill enhancement programs & workshops for Industrial personnel's.

Now this Memorandum of Understanding is witnessed as under:

1. The purpose of the collaborative relationship contemplated by this MOU is for setting up Atal Incubation Centre to develop the new business venture and create sustainable social and economic value with the assistance of the resources located within the Centre, while simultaneously advancing the NIELIT AURANGABAD's and the CMIA's research, educational, promotional, and strategic business partnership goals. The undersigned parties will put forth a good faith effort in providing resources, both tangible and intangible, in assisting each other in this collaborative relationship to achieve their respective goals.
2. Through the faculty and staff of the NIELIT AURANGABAD to be affiliated with MAGIC, NIELIT AURANGABAD agrees to provide academic support to the CMIA for the MAGIC project on a good faith basis which shall include:
 - 2.1 Giving Access to the strategic and knowledge expertise of the NIELIT AURANGABAD in all the departments and courses of NIELIT AURANGABAD in all the disciplines available.
 - 2.2 Participation in Educational Workshops and Events conducted by both CMIA and NIELIT AURANGABAD for MAGIC.
 - 2.3 Referral of Eligible Undergraduate, Post-Graduate and PhD Projects of the students of NIELIT AURANGABAD which have potential of developing into scalable business models
 - 2.4 Mentoring and Coaching for Business Plan Development and overall appeasement of business Startup ideas
 - 2.5 Media Publicity and Promotion through Press Notes etc. regarding strategic partnership between NIELIT AURANGABAD and CMIA for MAGIC project
3. CMIA through its Office Bearers and staff of the MAGIC, agrees to provide the following services to NIELIT AURANGABAD, as appropriate, on good faith basis:
 - 3.1 Promotion of the NIELIT AURANGABAD through various mediums, including, but not limited to, media and web sites, to recognize the collaborative efforts of the MAGIC;

- 3.2 Adoption of ~~Eligible Business~~ Startup Ideas emerging from the Undergraduate, Post-Graduate and PhD Projects of the students of NIELIT AURANGABAD as per the criteria mutually set out by both CMIA and NIELIT AURANGABAD for incubation and acceleration at MAGIC facilities;
- 3.3 Consider the NIELIT AURANGABAD's graduates and students for internships and employment at member companies of MAGIC and CMIA
- 3.4 Assisting NIELIT AURANGABAD for academic workshops, entrepreneurship development events etc. in relation to the proposed activities of MAGIC.
4. Unless otherwise provided, both CMIA and NIELIT AURANGABAD shall work jointly for prospering the membership drive of the MAGIC and shall ensure welfare of MAGIC activities along with other members of MAGIC.
5. NIELIT AURANGABAD will extend the necessary academic and mentoring support to the new entrepreneurs under incubation at MAGIC and existing entrepreneurs for accelerator program at MAGIC. Such entrepreneurs shall not only include students and graduates of NIELIT AURANGABAD, but shall also include students and graduates of other institutions and colleges in Marathwada region.
6. This MOU does not constitute any kind of economic commitment from either of the parties to the other party or to any other third person. It should not be construed as Contract of any kind.
7. Any of the clauses of this Memorandum of Understanding can be amended / altered / modified only with the written mutual consent of the both of the parties.
8. The collaborative relationship between NIELIT AURANGABAD and CMIA under this MOU is at will. This MOU can be terminated by upon unilateral discretion of either of the parties after giving 30 days' notice to the other party under this MOU.
9. Any notices with respect to this MOU shall be sent to the respective representatives at the respective addresses as mentioned hereinabove.
10. Any / all disputes between the CMIA and NIELIT AURANGABAD with respect to the interpretation of the clauses of this MOU shall be referred for arbitration to the person so nominated by CMIA under the Indian Arbitration & Conciliation Act whose decision shall be final and binding upon the parties. The place of arbitration shall be Aurangabad.
