4. Eligible Candidates are required to bring attested copies of the following documents/certificates along with Originals with the duly filled Application form: -
  - a) Matriculation/10<sup>th</sup> Class certificate showing Date of Birth/Proof of Age
  - b) Certificates of essential qualification (Both Mark lists and pass certificates) which makes him/her eligible for applying for the post applied for.
  - c) Certificate(s) of higher educational qualification, if any.
  - d) Community Certificate (SC/ST), if applicable.
  - e) Disability certificate (PwD), if applicable.
  - f) Requisite experience certificate(s) clearly mentioning the starting and ending dates of employment, which makes him/her eligible for applying for the post.
