## **How to Apply**

### **Candidates Must visit NIELIT Ch.Sambhajinagar campus to complete registration on skillindia portal**

Candidates have to bring the following documents along with Original copies and Soft Copy of the document verification:

- Self-Attested copy of Aadhaar Card / Any other Govt. approved Photo Id-Card
- Self-Attested copy of DOB Proof/X certificate
- Self-Attested copy of eligibility qualification certificates and marksheets
- Self-attested copy of Caste certificate in case of SC/ST candidate
- Two recent passport size photographs

After checking of all eligibility documents. Batch code, roll no. will be allocated. Final registration process of candidate will be completed through SKILL INDIA PORTAL(SIP) which is to be done by the NIELIT Delhi. For registration on Skill India Portal, the candidate has to bring the soft copy (JPEG/JPG format, size less than 50 KB)of above mentioned documents.

## Terms and Conditions

- The candidate must possess an Aadhaar card linked with Bank Account.
- In case, the course is cancelled/postponed due to some technical/administrative issue at NIELIT or MSDE side and new date is not convenient to the candidate, NIELIT shall not be responsible for any consequential damages.
- Candidate can apply to enroll in single course only.
- All course related updates / announcements / information would be sent to the registered mobile no. / e-mail ID of the candidate.
- In case of non-submission of required documents within stipulated time, the admission can be cancelled and seat will be offered to the next candidate.
- In case, any enrolled candidate could not join the course or found ineligible after document verification or could not come for document verification at the scheduled dates or inadvertently applied for the course or any other reason, then seat will be allotted to next candidate.
- If any of the information provided by the shortlisted candidate is found false/incorrect or discrepancy is found in the information furnished online and the original documents, can lead to cancellation of admission.
