In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 1. Buyer Added text based ATC clauses
  - 1.1 The NIELIT Campus is situated at NIELIT Chandigarh's permanent campus at Vill. Bada Phull, Rupnagar 140001. The scope of work includes Mowing, Strimming, Laying, Sweeping, Watering, Weeding, Removal and disposal of unwanted Vegetation and weeds, Applying Fertilizers, Applying Pesticide, Trimming & Pruning, Planting and Maintenance of Trees/Plants/Grass and potted plants, Adding ornamental features, Cleaning of Drains and other such activities.
  - **1.2** All consumables required for the work / maintenance including fertilizers, pesticides, seeds, etc. are to be provided by the service provider.
  - **1.3** If desired, the vendor may visit the campus before submitting bid.
  - 1.4 Payment shall be made on a quarterly basis within 30 days after satisfactory completion of quarter upon submission of tax invoice.
