Buyer Added Bid Specific Additional Terms and Conditions

- Buyer Added text based ATC clauses
 - 1.1** The NIELIT Campus is situated at NIELIT Chandigarh's permanent campus at **Vill. Bada Phull, Rupnagar** - 140001. The vendor will be required to supply the items listed in the Specifications along with replacement warranty of minimum 6 months.
 - 1.2** The supplied compatible cartridges must have a minimum shelf life as per the Specifications.
 - 1.3** The bidder needs to submit valid OEM Authorization Certificate (MAF) for OEM Original Toners/Cartridges/items required in the BOQ.
 - 1.4 Warranty:** The vendor shall also provide replacement warranty of minimum 6 months for supplied items during which period any defective/incompatible item/non-OEM cartridge (where original OEM cartridge required as per specifications) will be required to be got replaced on-site by the vendor within 15 days of intimation and the defective items will be picked up at vendor's cost.

1.5 If the page yield of sample taken out of supplied cartridges is found to be lower than the minimum specified yield, the payment shall be proportionately reduced as per the actual yield for the complete cartridge type lot in each case.

1.6 Payment shall be released within 30 days after delivery of complete lot upon receipt of tax invoice.

1.7 Time Schedule

i) The vendor shall complete the supply of the items before within 21 days of the award of contract.

1.8 Penalty Clause / Liquidated Damage

In case the vendor fails to meet the requirements of AMC / maintenance/ warranty conditions laid down in this document, penalty will be imposed at the rate of 1% per week. If the vendor fails to replace the items even after 10 days, NIELIT Chandigarh reserves the right to get the same replaced at vendor's risk and cost.

2. **Upload Manufacturer authorization:** Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
