Applicants are required to submit the filled Application Form along with the documents on the day of interview i.e. on **22-12-2024 (Sunday)** between **11:00 AM** to **02:00 PM** at NIELIT NIELIT Dehradun Study Centre, Institute of Engineers, Engineer’s Bhawan, Near ISBT, Dehradun, Uttarakhand. Only after successful submission of the Application Form, the candidate may appear for interview.
3. Successful submission of application will be considered only after receipt of prescribed fees. NIELIT Haridwar shall not be responsible for any broken transaction during online payment process.
4. Incomplete applications will be summarily rejected and no request of fee refund will be entertained in this regard. Mere fulfilling the essential qualification/experience does not guarantee selection or call for interview.
5. Candidates are required to bring self-attested copies of the following documents/certificates with the Application form to be submitted:-
