- 1. The Vendor should have minimum three years of experience in installation of CCTV cameras and security and surveillance system projects.
- 2. The vendor must have knowledge and experience of implementation of electronic security systems including access control, surveillance and required software for monitoring.
- 3. The vendor also must have an established service base in Nagaland.
- 4. Capability of vendor to complete this task within 30 days.
- 5. Proof of registration with sales tax, service tax/GST is essential and copies of the proof should be submitted.
- 6. The company should have sound technical support staff for attending to complaints within 24 hours in Chuchuyimlang, Mokokchung.
- 7. The vendor should provide organization details and support staffs as per Annexure I.
- 8. The company should have at least three similar CCTV SITC purchase order successfully with any Govt./ Private Organization. Proof of such contract should be produced.
- 9. The company should not be black listed by any PSU banks/Govt. organizations. Self declaration should be submitted by the authorized official of the company.
- 10. The company should have satisfactorily completed similar works during the last 3 years. (attach copy).
- 11. Any Company/firm interested to participate in the Tender must visit the site/location with their Technical Team and attach site survey certificate along with Tender signed by the officer in-charge otherwise tender will be cancelled.

TERMS AND CONDITIONS:

- 1. The work consists of supply, Installation, testing, commissioning of Closed-Circuit Television (CCTV) system in accordance with the technical specifications, terms and conditions mentioned in tender documents.
- 2. The specification of the equipment supplied should be equivalent or higher than the specifications mentioned in the tender document and the vendor should specify the brand/model/make in their technical offer.
- 3. The cameras installed should cover maximum area.
- 4. The tender(s) received after the due date shall be summarily rejected, and not taken into consideration.
- 5. All product brochures, technical documentation/specifications of CCTV cameras, DVR and LED TV should be enclosed with the quotation.
- 6. Conditional/Unsolicited tenders shall not be considered.
- 7. If required, the bidder can be called for an on-site demo to evaluate the quality of recording and video file out puts of the quoted CCTV equipment before it is approved.
- 8. The manufacturers/their authorized stockiest /dealers will have to submit their registration certificate from the authority concerned, GST registration certification.
- 9. Every tender should be accompanied with an earnest money of **Rs. 10,000/- (Rupees Ten thousand only).** The Earnest Money should be deposited online and the receipt should be enclosed with the Tender. Tenders received without requisite Earnest Money will be rejected out rightly.

The prices quoted in the Financial Bid should be inclusive of all taxes and includes equipment, installation charges, materials, labor, tools, appropriate cabling and necessary management for completion of the work. The vendor should quote the prices for providing complete solution. After placing the order, Department will not pay any extra amount which is not mentioned in the financial bid.
- 11. Complete specifications of the items should be given with the name of the manufacturers in the quotation / tender. Offers vaguely described or incomplete offers are liable to be ignored.
- 12. The successful vendor should complete the work within 30 days from the receipt of order and failure to commence the work within seven days, the Department will forfeit the EMD.
- 13. EMD will be returned to all the unsuccessful bidders within 15 days.
- 14. For successful bidders, EMD will be returned after 3 months only after the successful installation, commissioning and testing of the system.
- 15. Number of locations and Cameras may be increased or decreased or changed.
- 16. After successful installation and testing, vendor has to impart the training without any cost to the officers of the Department to operate the equipment.
- 17. The entire CCTV system supplied & installed should be under on-site warranty as specified against all types of defects from the date of handing over of the product to the Department. Any defects found in the product/sub-product within the warranty period shall be rectified / replaced by the Vendor free of cost. During this period of warranty, servicing at quarterly interval or earlier without any additional cost to the Department besides attending to call back services in case of break down, as prescribed by the manufacturer and as mutually agreed to, shall be carried out free- of-cost. This includes replacement of all parts and spare parts and any number of break down call.
- 18. Please note that Department will apply penalty as below in case of discrepancy in services under warranty period:
 - a) On receiving complaint about equipment/ services, the Vendor will promptly respond and repair/ replace or provide required services within 24 hours, if failed, penalty shall be levied Rs. 500/- per day;
 - b) If Department observe any unsatisfactory services after sales, discipline/ conduct, delay in repair / maintenance, then Department will forfeit the EMD and black list the company / firm.

- 19. The Vendor should submit the bill after completion of work and submission of report from the Officer Incharge, NIELIT Extension Centre, Chuchuyimlang that the work was carried out satisfactorily and as per specification. Advance payment is not permissible.
- 20. The Director, NIELIT Kohima is not bound to accept the lowest tender and also reserves the right to reject any or all tenders at any time without assigning any reason.
- 21. The Director, NIELIT Kohima taking note of overall facts and circumstances can change, add and relax any of the terms and conditions of this tender notice.
- 22. All the Tender documents should be signed by the Vendor to accept all the terms & Conditions.

- The Vendor will submit bids in two separate sealed envelopes i.e. one Technical Bid and second Financial Bid as
 per format. Each envelope must be suitable inscribed as "Technical Bid" and "Financial Bid" respectively to

 Administrative Section of NIELIT Kohima.

- The Vendor should fulfill prequalification conditions of the tender.
- The Vendor should submit all the documents attested by authorized person with the quotation.
- The technical bid will be opened first in the presence of the Tender Committee Members and bidders. Financial bids of only technically qualified bidder shall be opened in the presence of the Tender Committee Members and bidders. The bidders, if they wish, may remain present.
