The recruitment of Cyber Security Analyst with Advertisement Ref. No. NIELIT/KMA/01/02/04-ADMN Dated. 21-09-2022, has been cancelled due to non-fulfillment of required qualification & experience. Therefore, candidates who have applied earlier may apply as per the qualification & experience mentioned with this advertisement.

1. The engagement is on a short-term contract purely on a temporary basis on consolidated remuneration initially for a period of 6 months, which may be further extended based on performance and requirements. No. of the post advertised may vary depending upon the requirement. The place of posting for Sl. No. 1 to 3 is for Kohima and Sl. No. 4 can be posted at any Centres under NIELIT Kohima.
2. Applicants should register their names in the following Google Form on or before **24<sup>th</sup> November 2022, 2:00 PM**. In case the candidate is applying for more than one position, a separate application form for each position has to be filled out and submitted.
3. Interview for the positions shall be held through Online/Offline mode. In case of Online mode of interview, applicants shall ensure availability of Desktop PC/Laptop with Camera & speakers, network connectivity with proper bandwidth. NIELIT shall not be responsible for any disconnection during the interview or the candidate unable to join the Interview, such candidates shall summarily be rejected. Interview date shall be intimated through email/SMS.
4. In case Interviews are held online, candidates will be required to appear using either Jitsi/Google Meet/Cisco Webex/ Microsoft Teams/Zoom Meeting. Candidates are required to download the apps and shall be ready to attend the interview as per the time slot given. In case of offline interviews, the venue shall be NIELIT Kohima.
