Bids are required to be submitted through Government of India's e-Procurement (e-Tendering System) Website/Portal <https://eprocure.gov.in/eprocure/app> only, on or before the specified Bid Due Date & Time. Bidder(s) are required to register themselves at <https://eprocure.gov.in/eprocure/app>. No Registration fee would be charged from the bidders for the same.
3. No Manual Bids/Offeres shall be accepted. The offers submitted through the designated e-tendering system shall only be considered for evaluation & ordering. Bids submitted in physical form or sent in any other form such as through Telex/Telegraphic/ Fax/E-Mail /Computer floppy/ CD/DVD/Pen Drive etc. shall not be accepted.
4. Bidders, who are on "Holiday/ Negative List" or blacklisted by any Government Department / Public Sector on due date of submission of bid/ during the process of evaluation of bids, the offers of such Bidders shall not be considered for opening/evaluation/award.
