- 2. Quotations received after the due date and time will not be considered.
- 3. The Quotations should be valid for acceptance for a period of 90 (ninety) days from the due date and the commissioning & installation should be completed within the time frame mentioned above.
- 4. Quotations will not be accepted by Fax, Email or any such electronic data transfer form.
- 5. The Quotations should be for goods exactly conforming to our requirements and specifications.
- 6. The technical literatures along with certificate from original manufacturer of the LED Module & Power Supply to be used in the contract are required to be produced by the bidder / vendor selected for the work.
- 7. Setting up of signages work including the following:
 - (i) The selected bidder will be responsible for fabrication and erection of the signages as per approved artwork along with its maintenance and other trouble shooting, if any, within the warranty period.
 - (ii) Fabricationanderection of the complete signages in two different locations (two spots of the same building) as specified by NIELIT Kolkata along with electrical fittings, etc.—asper specifications approved by NIELIT Kolkata.

- (iii) Transportationofsignagesfromconverters' work placetothesite mentioned above.
- (iv) Provision of timer with automatic and manual operability.
- 8. Copy of Manufacturing License, Trade License as applicable, to be enclosed with the bid.
- 9. No Sales Tax Forms or Waybill will be provided by this office.
- 10. Paymentwill be made after completion of supply, assembly, installation and commissioning of the items covered by the order along with necessary spares supplied to the entire satisfaction of NIELIT, Kolkata Centre. **No advance payment will be made under any circumstance.**
- 11. Incomplete bids and bids which do not comply with all the above instructions are liable to be summarily rejected.
- 12. NIELIT, Kolkata does not bind itself to accept the lowest or any such quotations and has the right to accept or reject whole or any part of tenders or a portion of the supply of goods without assigning any reasons whatsoever. No correspondence in case of rejected tenders will be entertained.
