**Terms & Conditions:**

1. Applicants are required to apply online from **1<sup>st</sup> October 2022 to 6<sup>th</sup> October 2022** through the website <https://nielit.gov.in/delhi> (under Recruitment section). **No other mode of application will be accepted in any case.** In case the candidate is applying for multiple positions, separate Registration and application form for each position has to be filled. However, candidates applying for multiple positions are required to mention **the same e-mail id and contact number** in all applications.
2. The interested applicants are advised to go through the eligibility criteria carefully and ascertain themselves regarding their eligibility. The eligibility criteria, Performa for application Form and Link for Registration form is available at <http://nielit.gov.in/delhi>.
3. **Applicants are required to fill Registration form on or before 6<sup>th</sup> October 2022; 12:30 PM.** After Successful registration, candidates will be called for the Interview/ written test. The candidates will be informed through eMail / SMS regarding the schedule of interview/Written test. Only those candidate(s), who will be shortlisted after the Interview/Written Test and clear the Document Verification, will be empanelled as Consultant and Project Engineer and MTS.
4. Date of Interview/ written Test (if any) and Document verification will be informed after last date of submission of form. The same will be published at <http://nielit.gov.in/delhi>. Candidates are advised to check the website regularly. **Interview/Tests and Document Verification will be conducted at NIELIT Centre, Delhi.**
5. The empanelled candidates will be offered contractual employment as per requirement initially for the period of six months (which may be further extended based on requirements/performance of the candidate) or Co-terminus with the project whichever is earlier.
6. Final selection of candidates for hiring will be based on the performance of the candidates in the Interview and as found eligible as per prescribed criteria. **NIELIT reserves right to conduct written test or skill test for screening the candidate at any time during the process of empanelment, if felt necessary.**
7. No TA/DA will be provided to candidates for appearing for the Interview/Written Test/ Document Verification etc.
8. The place of deployment will be Delhi.
9. The qualification of the candidates must be from recognized University/Institution.
10. Candidates must bring at least one original Photo ID proof and all original Mark sheets/ degrees/ testimonials/ post qualification experience certificates (including the Experience letter of the current place of working)/ one passport size photo and their SELF ATTESTED photocopies on the day of the Document Verification otherwise they will not be allowed to appear in the interview. The cutoff date for calculating age, qualifications, experience etc. will be the last date of submission of the form i.e. **6<sup>th</sup> October 2022.** In case, last date is extended, the date of determining eligibility will not change. **Registration received after 6<sup>th</sup> October 2022; 12:30 pm shall not be entertained. Such applications shall be summarily be rejected.**

11. The name of the candidate in the application form must be the same as mentioned in the certificate of class X. In case the candidate has changed his name subsequent to Class X, the evidence to that effect should be furnished at the time of interview.
12. Canvassing/trying to influence NIELIT employees to secure the job in any manner shall disqualify the candidate.
13. NIELIT Delhi has the right to accept or reject the application without assigning any reason thereof.
