- NIELIT will create a panel in for contractual deployment. IT resource persons (Associate Faculty (Electronics/IT/ Multimedia), Assistant Faculty (Electronics/IT/ Multimedia/Accounts)) will be selected for deployment on contract from the panel as and when required. However, the panel will be valid for two years from date of declaration of result. The selected resource person from the panel will be deployed initially for 6 months which may be further extended based on performance of the candidate.
- 2. Applicants are required to go through the Eligibility criteria carefully and ascertain themselves regarding their eligibility before visiting.
- 3. Applicants must bring Self-Attested photocopies of Marksheets/degrees/testimonials/post qualification experience certificates (including the Experience letter of the current place of working), Valid photo ID on the day of the interview, otherwise they will not be allowed to appear in the interview. Cut-off date for calculating experience will be **22-10-2021**.
- 4. Applicants are required to submit the filled registration form along with the documents on the day of interview between 9:00 am to 12:00 pm at NIELIT Delhi Centre. After registration, the candidates may appear for the interview.
- 5. The qualification of the candidates must be from recognized University/Institution.
- 6. Applicants with last semester result awaited or incomplete degrees are not eligible to apply.
- 7. Name of the Applicant in application form must be same as mentioned in the certificate of class X. In case the candidate has changed his name subsequent to X, the evidence to that effect should be furnished at the time of interview.
- 8. No Application Fee will be charged for the walk in interview, demo lecture and document verification.
- 9. Canvassing/trying to influence NIELIT employees to secure the job in any manner shall disqualify the candidate.
