OFFICE ORDER

Consequent upon his selection to the post of Deputy Chief Commissioner in the office of Chief Commissioner for Persons with Disabilities (CCPD), Ministry of Social Justice, Government of India, in Pay Matrix 13, on deputation basis initially for a period of 3 years, Dr Janak Raj, Registrar, NIELIT is relieved from his duties and responsibilities in NIELIT Headquarters w.e.f. 30/09/2021 (AN) so as to enable him to report to the O/o CCPD on 01/10/2021.

2. The deputation of Dr Janak Raj will be initially for a period of three (03) years and shall be governed as per terms and conditions laid down in DoPT 's OM No. 6/8/2009-Estt (Pay-II) dated 17.06.2021. Further, while being on deputation to the O/o of CCPD, Dr Janak Raj has exercised the option of continuing with the Pay & Allowances and other facilities (as enumerated below) of the Parent Organisation i.e. NIELIT :


- i. Pay – Basic pay in the parent cadre. Presently, in Level 13 of 7th CPC and Pay in Level: Rs. 1,47,000/-
- ii. Current DA: @ 28% of Basic Pay
- iii. Current HRA: @27% of Basic Pay
- iv. Current Transport Allowance Rs. 14,400/- (on double rates being Person with Disability) and current DA on TA @ 28%
- v. Meal allowance @ Rs. 60/- per day of attendance (including Saturday/Sunday/ other holidays)
- vi. LTC – as per GoI Rules Applicable in NIELIT
- vii. Medical Facility –
 - a. For OPD - One month's Basis Pay + DA as on 1st Day of July every year, reimbursed quarterly on self-certification basis.
 - b. For IPD – Reimbursement at CGHS rates in Central / State Govt / NIELIT empaneled hospitals.
- viii. All other facilities - As per GoI rules applicable in my Parent Organisation i.e NIELIT
