#### **General Terms & Conditions:**

1. The number of vacancies are tentative and liable to change as per the requirement of NIELIT. Selected candidates may be offered appointment in order of merit as and when need arises.
2. The Remuneration mentioned above is consolidated salary. The selected candidate will not be paid any other financial benefits like Medical, HRA, Transport etc. except the consolidated salary.
3. The qualification of the candidates must be from recognized University/Institution.
4. The candidate must appear for document verification and Walk-in-Interview on the given date in the given time (as published in advertisement) only. Those reaching late shall not be entertained.
5. Only those candidates, who clear document verification, will stay for Walk-in-Interview. Others may leave the venue. Interview and document verification will be held on the same day.
6. Candidates must bring ALL original mark sheets, degrees, testimonials, DOB certificates, caste certificate (if applicable), experience certificate and SELF-ATTESTED photocopies of each document along with Aadhaar card (any Govt. approved photo id) and one passport size photo on the day of document verification.

7. Selection of candidates for appointment to the above mentioned position(s) will be based on the performance of the candidates in the walk-in-interview and as found eligible as per prescribed criteria.
8. NIELIT reserves right to conduct written test or skill test for screening of the candidate before interview, if felt necessary.
