PUBLIC NOTICE

“Beware of the fraudulent claims made by individuals/organizations regarding NIELIT DLC Facilitation Centers”

National Institute of Electronics & Information Technology (NIELIT) is an Autonomous Scientific Society under Ministry of Electronics & Information Technology (MeitY), GoI. NIELIT grants permission to Facilitation Centers for conducting Digital Literacy Courses (DLCs) across India. DLC is a bundle of five courses under Digital Literacy Program which includes ACC, BCC, CCC, CCC+ and ECC.

2. NIELIT grants status of NIELIT DLC Facilitation Center to the institutes on their requests and fulfillment of norms for a specific period. Further, online examination for courses under DLC is conducted by NIELIT and certificate is also issued by NIELIT under its own seal and signatures.

3. Several instances have been noticed where institutes are conducting NIELIT DLC without obtaining permission from NIELIT and issues certificates to candidates at their own. It is also noticed that institutes are using name and logo of NIELIT without obtaining permission from NIELIT and misleading general public. NIELIT objects and condemn all such unauthorized acts and free to take any administrative/legal action against such institutes/persons.

4. **For the ease of institutes willing to apply for NIELIT DLC Facilitation Center, NIELIT has authorized a few organizations to guide and facilitate prospective institutes for documentations and submission of applications to NIELIT. NIELIT has designated these organization as Master Organization to help prospective institutes for their registration as NIELIT DLC Facilitation Center. These organization, however, will not charge any fee on account of such guidance, except the normal fee specified to be charged by NIELIT. Under no circumstances Master Organization can charge higher fee from institutes applying for NIELIT DLC Facilitation Center through it then the fee applicable for institutes which are applying directly to NIELIT for this purpose. Fee for grant of NIELIT DLC Facilitation Center Status to conduct Digital Literacy Courses is Rs. 10,000/- + GST (@18% or as applicable) for a period of three years.
