"Scheme for free accreditation of NIELIT NSQF Courses along with accreditation of NIELIT O/A/B/C Level Courses"

National Institute of Electronics & Information Technology (NIELIT) is an Autonomous Scientific Society under Ministry of Electronics & Information Technology (MeitY), Govt. of India. NIELIT is offering accreditation for O/A/B/C level Courses and the process of accreditation is carried out by NIELIT HQ, New Delhi.

2. Due to Covid-19 pandemic many institutes were shut and educational institutes are affected.

3. It is hereby by informed that, as an initiative to help these institutes NIELIT has decided to extend its course basket for O/A/B/C Accredited Centers. Existing & New Accredited Centers may be given up to five additional NSQF aligned courses without any additional fee along with existing O/A/B/C course for which the institute is accredited. The provisions related to this scheme has already been made by NIELIT in its portal.

4. A parity of courses which can be offered along with O/A/B/C Level Courses is as follows:

5. If an existing O/A/B/C accredited institute is interested to apply for Accreditation of additional NSQF Course (max. upto 5), the institute will have to do following additional formalities:

i) Institute will have to submit an undertaking as per format prescribed by NIELIT mentioning that it has all prerequisites for conducting the course like H/w, S/w, Faculty, infrastructure etc. No physical inspection will be conducted by NEILIT to award accreditation for aforementioned courses, it will be on Self-Certification Basis, however, surprise visit may be conducted by NIELIT.

ii) If the institute does not have faculty for teaching the course then one of the faculty from institute may get certified in that course, through NIELIT Centers/NIELIT NSQF Training Partner or through NIELIT Virtual Academy.

iii) On receipt of application and its verification, Accreditation Section NIELIT HQ will add the requested Courses in the login of that institute.

6. If an institute is registered for then one Level out of O/A/B/C then it can apply for max. 5 courses only. However, the institute must apply based on highest level (out of O/A/B/C) for which it is registered so that it can available wide range of courses to choose.

7. An accredited institute can apply for maximum five NSQF courses simultaneously or in phased manner one by one as per its willingness to start the course and demand.

8. As the accreditation for these NSQF courses is given based on self -certification by the institute, at the time of surprise visit if discrepancy/deviation is found from the norms then accreditation can be withdrawn by NIELIT.

9. It may be noted that the validity of NSQF aligned courses is for a specific duration and courses are approved by NCVET after due deliberations in NSQF approval committee. Hence, the above list of courses is tentative and courses can be added/deleted in the list as per their NSQF validity. Further, if at particular time if a course is not aligned or its NSQF validity is expired then NIELIT will not allow registration in that course.

10. It will be the responsibility of accredited institute to ensure that the NSQF course in which the institute is taking admission is NSQF aligned at that time. Qualification Files consisting of validity (Date of planned review) of a NSQF course is available at National Qualification Register (<u>https://nqr.gov.in/</u>). NIELIT will not be responsible for any liability if an institute takes admission in a course which is not valid at that time.

11. An institute can choose maximum five courses irrespective of no. of O/A/B/C levels for which the institute is accredited with NIELIT. There is no provision for replacement of a course, a course once chosen cannot be replaced with any other course.

12. In all matters related to this scheme, the decision of Competent Authority NIELIT will be final and binding.

13. NIELIT reserves the right to discontinue/amend this scheme anytime without assigning any reason.
