

## **MINUTES OF THE 25<sup>TH</sup> MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE (NSQC) HELD ON 25<sup>TH</sup> JUNE, 2020**

The 25<sup>th</sup> meeting of the National Skills Qualifications Committee (NSQC) was held on 25<sup>th</sup> June, 2020 through video-conferencing, under the Chairpersonship of Shri. Praveen Kumar, Chairman, NSDA and Secretary, MSDE. The list of participants is at Annexure I.

At the outset, DG- NSDA welcomed all participants for the meeting. She briefed NSQC about the agenda of the meeting which was taken up for detailed discussion. She also informed the Committee that due to lockdown on account of COVID-19, stakeholder consultations were carried out through emails and telephonic calls.

### **AGENDA ITEM 1: CONFIRMATION OF MINUTES OF THE 24<sup>TH</sup> MEETING OF NSQC**

The Committee approved the minutes of the 24<sup>th</sup> meeting of NSQC held on 27<sup>th</sup> February, 2020.

### **AGENDA ITEM 2: ACTION TAKEN REPORT ON THE MINUTES OF THE 24<sup>TH</sup> NSQC**

NSQC took note of the action taken and approved the same, with following decisions -

- The qualification 'Hardware & Networking Associate' of HARTRON, Haryana was approved in the 24<sup>th</sup> NSQC subject to change in nomenclature from 'Associate' to 'Assistant'. HARTRON requested to retain the original nomenclature as the qualification was of level 4. NSQC approved the same (Annexure II).
- NSQC was informed about the 8 files of NIELIT which were earlier placed in the 23<sup>rd</sup> NSQC and approved in the 24<sup>th</sup> NSQC subject to certain compliances. NSQC was informed that NSDA facilitate a meeting of NIELIT with MeitY and AICTE and resolved the issue. The files were uploaded on NQR (Annexure III).
- On the 2 DGT qualification files – 'Old Age Care' and 'Health Sanitary Inspector' which were conditionally approved in the 24<sup>th</sup> NSQC, NSQC reiterated that no new enrolment will be done in these qualifications unless MoHFW approves them in totality. NSQC also directed DGT to send the qualification file 'Health Safety and Environment' to MoHFW for their comments at the earliest.

### **AGENDA ITEM 3: QUALIFICATIONS SUBMITTED FOR NSQF ALIGNMENT**

DG-NSDA informed NSQC that 91 qualifications (80 new and 11 revised), received up to 29<sup>th</sup> February, 2020, were being considered in the NSQC. DG-NSDA gave a brief snapshot of the qualifications being considered for NSQF alignment, after following due process and scrutiny.

A consolidated statement of approval status of Qualifications in the 25<sup>th</sup> NSQC is placed at Annexure IV. The sector-wise/submitting body wise discussions and decisions taken are given below:

#### **1. Qualifications submitted by Central Ministries**

- I. **Directorate General of Training (DGT)** : A total of 41 CITS qualification files pertaining to 12 sectors were presented for approval. All files were approved with the condition that the entry requirement would be changed from Diploma (with or without prefix of number of years) with 'AICTE approved Diploma'.
- II. **Cotton Corporation of India , Ministry of Textiles**: 1 new qualification file placed for consideration of NSQC, was approved.
- III. **CIPET** : 1 existing file with no changes, was placed for extension of review date. The same was approved by NSQC for 3 years.

#### **2. Qualifications Submitted by Sector Skill Councils**

- I. **NASSCOM SSC** : A total of 5 files were submitted by the SSC. All 5 files were approved with the following modifications:
  - The entry requirement of 'Minimum 21 years of age' in all the qualifications to be removed.
  - The entry requirement of 'Work Experience' mentioned in all the qualifications, to be specified as full-time work experience. The full time experience would include work, internship and apprenticeship undertaken post completion of regular graduation.
- II. **BFSI SSC**: One qualification file submitted by the SSC was approved by the Committee.

III. **Life Science SSC:** Three qualification files were submitted by the SSC for approval of NSQC.

The qualification- 'Pharmacovigilance Associate' was approved subject to approval by MoHFW being received. MoHFW was requested to send their comments within 30 days.

The 2 qualifications on –'Bioinformatics Associate/Analyst' and 'Bioinformatics Scientist' were approved by the Committee.

IV. **Handicraft and Carpet SSC:** 20 qualification files were submitted by the SSC. All files were approved subject to following compliances :

- a) Wherever possible, proficiency in previous NSQF level should also be included in the entry requirement. Minimum work experience should be included in the entry requirement. Generally 1 year of experience for level 5 qualifications and 3 years for level 6 qualifications should be the yardstick. It was informed by the SSC that although for all the 20 qualifications, work experience had been included, necessary changes as suggested by the NSQC would be carried out.
- b) The NSQF level of 'Tufted Weaving Supervisor (Carpets)' qualification to be brought down from level 5 to level 4.

V. **Rubber SSC:** 10 existing qualification files, with certain changes, were submitted by the SSC for approval of NSQC. Committee approved all the qualifications.

VI. **Management SSC:** One qualification file 'Paralegal Associate-Legal Documentation' was submitted by the SSC. The file was approved, subject to Management SSC seeking a clearance from the Bar Council of India. This should be done and re-submitted to NSDA before the 26<sup>th</sup> meeting of NSQC.

VII. **Instrumentation SSC:** The 4 qualifications submitted by the SSC , were approved with following modifications:

- For the qualification 'Cabling Technician', the occupation to be redefined as "Laying of Cables and Termination" in place of "Installation and Commissioning; Operation and Maintenance".
- For the qualification 'PLC Programmer and Trouble Shooter', "ITI in relevant trade with 2 years of work experience" to be included in the entry requirements.





### 3. Qualifications submitted by States

I. **ASAP, Kerala:** One qualification file was presented to NSQC for NSQF alignment. The qualification was approved with following modifications:

- The word 'Trainee' in the occupation of the qualification to be removed. The resulting occupation to be kept as "Software Engineer/Project Engineer".
- In the entry requirement, "Students pursuing degree" to be replaced by "Students pursuing engineering degree and have completed at least 5 semesters".

#### II. **HARTRON, Haryana:**

The 2 files submitted by HARTRON for approval of NSQC, were approved with the following modifications:

- In both the qualification files, the entry requirement of 'basic knowledge of computer' to be replaced by 'Preference will be given to candidates with certificate in any computer course'.

### 4. Qualifications submitted by University

#### 1. **Shri Vishwakarma Skill University(SVSU)**

1 qualification file- 'Post Graduate Diploma in Geo-Informatics' was submitted by SVSU, Haryana. It was decided by the NSQC that as 'Diploma' was under the purview of AICTE, NSDA may consult AICTE on the regulatory body competent to give permission for the same. The qualification may be considered approved only after receiving the comments and concurrence of AICTE.

#### **AGENDA ITEM 4: APPROVAL OF QUALIFICATIONS OF ASAP, KERALA**

NSQC was informed that the qualification-'Child Care Associate' submitted by ASAP, Govt. of Kerala was conditionally approved in the 23<sup>rd</sup> NSQC meeting subject to comments of MoHFW. Based on MoHFW's recommendations, the content of the qualification was split into two new qualifications- 'Child Health Assistant' & 'Child Care Aide'. These were re-submitted by ASAP after incorporating the changes proposed by MoHFW, for consideration of NSQC.

NSQC approved both the qualifications.

#### **AGENDA ITEM 5: EXTENSION OF REVIEW DATE OF 1709 QUALIFICATIONS TILL MARCH 2021**

A proposal was received from NSDC for extension of the date of review of 1709 qualifications till March 2021.

NSQC approved extension of review date till March 2021, only in respect of qualifications whose original review date was before March 2021. NSDC was advised to send a list of such qualifications to NSDA.

#### **AGENDA ITEM 6: FOR INFORMATION OF NSQC**

##### **1.Experimental Approval to Qualification in Gems and Jewellery Sector**

NSQC was informed about the grant of approval to the qualification of Assayer, of the Gems and Jewellery Skill Council of India, under the experimental approval guidelines notified by NSDA on 2nd April, 2020. NSQC noted the same.

#### **ADDITIONAL AGENDA ITEM 7: INTERIM APPROVAL OF "AGARBATTI PACKER" FOR PwD**

The Committee was apprised that in the 20<sup>th</sup> NSQC meeting, post facto approval for NSQF alignment was accorded to job roles of 'Agarbatti Maker' and 'Agarbatti Packer' till March 2018 (being implemented under PMKVY). However, as both job roles had a number of NOS's in common, as per stakeholder recommendation they were merged into one Qualification- 'Hand-rolled Aggarbati Maker' (submitted by Handicrafts& Carpet SSC), which was placed in the NQR.

It was further informed that the Skill Council for Person with Disability (SCPwD) had adopted the job role of 'Agarbatti Packer' and aligned it to various disabilities. Presently, training in this job role was going on under the SIPDA, Scheme of DePWD, MoSJE, for which assessment and certification was being done by SCPwD. SCPwD requested for interim approval for continuation of this job role to facilitate assessment & certification of current batches under the SIPDA. NSQC noted the same and accorded interim approval for continuation of the job role of 'Agarbatti

Packer' only for PwD , for completing assessment & certification of the current batches under the SIPDA scheme.

In the meantime, SCPwD along with Handicraft & Carpet SSC will submit a new Qualification (only for PwD) as per their requirement.

**Additional Agenda Item 8: Any Other Item**

Following directions were also given during the meeting:

1. NSQC may examine a separate qualification for vocational courses in schools which are more in nature of orientation towards the vocation, and not for taking employment.
2. Before bringing any proposal to NSQC, the office should identify and correct all discrepancies/ factual errors during desk top scrutiny.
3. Next NSQC meeting may be held in the last week of July, 2020

The meeting ended with a vote of thanks to the Chair.
