MINUTES OF THE 39th MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE (NSQC) HELD ON 25th JULY 2024

The **39**th **meeting** (Phase I) of the National Skills Qualifications Committee (NSQC) was held on **25**th **June, 2024** through online mode, under the Chairpersonship of Shri Atul Tiwari, Chairperson, National Council for Vocational Education and Training (NCVET). The list of participants is at **Annexure I.** The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

1. AGENDA ITEM 01: Confirmation of the Minutes of the 38th Meeting of NSQC held on 30th May 2024

- **1.1.** The Committee was apprised that the Minutes of the 38th meeting of NSQC were circulated and no comments were received.
- 1.1.1. The Committee was further apprised that one observation regarding 37th NSQC have been received from Army Training Command (ARTRAC) where the date of approval by NSQC for one qualification namely "Livestock Health Supervisor" of Remount Veterinary Sciences under the 'List of Amendments/Change in Nomenclature of Previously Approved Qualifications of Various Defense Awarding Bodies' was erroneously mentioned as 35th Meeting of NSQC dated 31st January 2024. The corrected date of approval by NSQC for this qualification is 32nd Meeting of NSQC dated 29th September 2023.
- 1.1.2. The Committee confirmed the Minutes of the 37th and 38th meetings of the NSQC along with the above correction.

2. AGENDA ITEM 02: ACTION TAKEN REPORT ON THE DECISIONS TAKEN IN THE 38^{TH} MEETING OF NSQC

- 2.1 A detailed account of the action taken was presented before the Committee in the Minutes of the 38th meeting of NSQC. The Committee acknowledged the action taken and approved the same and further emphasized the following:
 - 2.1.1. Introducing a system of Re-assessment and fixing the minimum pass percentage for Skill Based Courses in VETS
 - **2.1.1.1.** The Committee was apprised that a system of re-assessment is being introduced for Skill-Based Courses in VETS, along with the fixation of a minimum pass percentage and the recommendations are being finalized.

2.1.1.2. The Committee took note of the status.

2.1.2. Unavailability of Trainee's and Trainer's Handbook for PMKVY 4.0 Qualifications

- 2.1.2.1. In the 38th meeting of NSQC, the Committee had directed all ABs (SSC) to submit Trainee's Handbooks and Trainer's Handbooks for all PMKVY 4.0 Qualifications earliest by 9th June 2024 for implementation of PMKVY Qualifications.
 - **2.1.2.2.** The Committee was apprised about the status regarding the submission of Trainee's and Trainer's handbook by ABs (SSC). The Committee was informed that all ABs (SSCs) except the following had submitted the Trainee's and Trainer's Handbook for PMKVY 4.0 Qualifications.

- 2.1.1.1. The Committee took note of the status and directed the three (03) ABs (SSC) to submit them before the next NSQC.
- 2.1.1.2. The Committee further directed that the detailed list of all the Handbooks received from the ABs (SSCs) be drawn and approved on file for record-keeping purposes.

3. AGENDA ITEM 03: PROPOSAL OF THE DIRECTORATE GENERAL OF TRAINING (DGT) FOR RATIONALISATION/ ALIGNMENT TO NCRF/ NSQF LEVEL IN RESPECT OF 95 CRAFTSMAN TRAINING SCHEME (CTS) QUALIFICATIONS

3.1. During the 16th NSQC meeting on February 24, 2022, the Committee granted an "inprinciple" approval to the Directorate General of Training (DGT) for restructuring and rationalizing CTS and CITS Qualifications. The directive required all CTS/CITS Qualifications to be revised from 1600 hours to 1200 hours, include a mandatory 150 hours of On-the-Job Training (OJT) or Group Projects, with an optional additional training of up to 240 hours in short-term courses, including language subjects. DGT subsequently restructured their 150 CTS Qualifications and submitted them to the NCVET, committing in writing to adhere to the guidelines set forth in the 16th NSQC

meeting. These qualifications were approved "On File" and ratified in the 22nd NSQC meeting held on August 25, 2022.

- **3.2.** The Committee was apprised that following the adoption of the National Credit Framework (NCrF) in the VETS ecosystem and the notification of the revised NSQF, a review of these CTS Qualifications was conducted. It was found that the NSQF levels for 95 of these qualifications did not align with the levels prescribed in the NCrF/NSQF. As a result, the DGT was requested to review and update these qualifications in accordance with NCrF/NSQF guidelines and resubmit them to the NCVET for approval by the NSQC.
- **3.3.** The Committee was further apprised that accordingly a proposal from the DGT has been received, indicating that the levels of 95 CTS Qualifications need to be rationalized and aligned with NCrF and NSQF. DGT has requested approval from the NCVET for the revised levels, as all CTS qualifications are valid until August 2025. Further DGT plan to submit the revised syllabus and qualification files in the new format, adhering to the updated NCrF/NSQF levels during this revision process. Moreover, DGT has also submitted a tentative plan for the revision of all 150 CTS Qualifications. According to this plan, the updated qualifications will be submitted in a phased manner, starting from September 2024.
- 3.4. The Committee took note of the status and approved the agenda.

4. AGENDA ITEM 04: PROPOSAL OF THE DIRECTORATE GENERAL OF TRAINING (DGT) SEEKING RELAXATION FOR ENTRY QUALIFICATIONS IN CRAFT INSTRUCTOR TRAINING SCHEME (CITS) COURSES

- 4.1. During the 16th NSQC meeting on 24.02.2022, an "in-principle" approval was granted for the restructuring and rationalization of CITS and CTS courses proposed by the DGT. Subsequently, the DGT revised all CITS courses, reducing the duration from 1600 hours to 1200 hours, including trade theory, practicals (with WCS and ED for engineering trades, soft skills for non-engineering trades), training methodology, and a mandatory 150 hours of OJT/Group Project. An option for additional training of up to 240 hours on short-term courses, including language subjects, is available. The NSQC approved these changes for 55 CITS courses at its 31st meeting on 31st August 2023. The NSQF level for all CITS courses is set at Level 5, with entry criteria requiring appropriate experience: one year after a 2-year CTS or two years after a 1-year CTS.
- **4.2.** The Committee was informed that after detailed discussions, it was decided to review the NSQF levels for CITS courses. It was decided to exclude the one/two-year experience requirement from the entry criteria and instead bring down the NSQF level

of CITS to three different NSQF levels—3.5, 4, and 4.5 considering the difficulty faced by the CITS aspirants based on the entry qualifications of CTS courses (8th + CTS, 10th + 1 Yr CTS, or 10th + 2 Yrs CTS). Accordingly, the DGT submitted a revised proposal with modified NSQF levels. The details are as given below;

- 4.3. The Committee was apprised that the revised proposal from the Directorate General of Training (DGT) aligns with NSQF/NCrF standards and aims to address issues of low admissions and candidate hardships for CITS courses. The Chairperson of NCVET had approved the proposal, with the condition that the DGT prioritize revising the CITS courses for implementation in the upcoming session starting in September 2024. Additionally, the DGT is tasked with developing progression pathways for candidates to advance from lower to higher CITS levels, consistent with NCrF provisions.
- 4.4. The Committee took note of the status and ratified the agenda. The Committee further emphasized that DGT must complete the revision of the CITS courses for implementation before upcoming session starting in September 2024.

5. AGENDA ITEM 05: RATIFICATION OF ONE (01) QUALIFICATION OF UTTAR PRADESH STATE COUNCIL FOR VOCATIONAL TRAINING (UPSCVT)

5.1. The Committee was apprised that the Uttar Pradesh State Council for Vocational Training (UPSCVT) had granted provisional recognition as an Awarding Body (AB-Dual) by NCVET. Subsequently, UPSCVT had submitted one (01) qualification namely "Chikankari and Zardosi Artisan" pegged at NSQF Level-3 with 600 total Notional Hours, for NSQF alignment and approval. The qualification was reviewed in accordance

with the prescribed criteria and approved on-file vide File No. 36003/19/2024/NCVET dated 4/07/2024 on an urgent basis owing to the requirement of signing of AB agreement with UPSCVT.

5.2. The Committee took note and ratified the qualification.

6. AGENDA ITEM 06: RATIFICATION OF 01 (ONE) NOS & 01 (ONE) MICRO CREDENTIAL OF DIRECTORATE GENERAL OF TRAINING

- 6.1. The Committee was apprised that the Government of India launched the PM Surya Ghar Muft Bijli Yojana on 29th February 2024 to boost solar rooftop capacity and empower households to generate electricity by installing 1 crore rooftop solar systems. The DGT has been appointed as the nodal agency for the components implemented by the Ministry of Skill Development & Entrepreneurship (MSDE). DGT will train 1 lakh trainees in "Rooftop Solar PV (Installation & Maintenance)" through a 60-hour program, including 15 hours of OJT, at NSTI(W)/NSTIs/ITIs.
- 6.2. The Committee was further apprised that in consultation with the Ministry of New and Renewable Energy (MNRE) and industry experts, DGT has developed one NOS namely "Rooftop Solar PV (Installation & Maintenance)" pegged at NSQF Level 3 with 60 Notional Hours for trainees and one Micro Credential namely "Rooftop Solar PV (Installation & Maintenance) Trainer" pegged at NSQF Level 4 with 15 Notional Hours for trainers. Subsequently, DGT had requested urgent approval from NCVET for these NOS/Micro-Credentials to ensure the scheme's success. Keeping in view the urgency to commence the training, one (01) NOS & one (01) Micro Credential were reviewed in accordance with the NSQF norms and approved 'on file' by the competent authority vide F No: 36001/84/2022/NCVET dated 24/06/2024.

6.3. The Committee noted and ratified the two qualifications.

7. AGENDA ITEM 07: RATIFICATION OF ONE (01) QUALIFICATION RECEIVED FROM NATIONAL INSTITUTE FOR ENTREPRENEURSHIP AND SMALL BUSINESS DEVELOPMENT (NIESBUD)

- 7.1. The Committee was apprised that NIESBUD had granted provisional recognition as an Awarding Body (Dual) and had submitted one (1) qualification namely "Organic Farming Micro-Entrepreneurs" pegged at NSQF Level 2 with 240 Notional Hours for approval. Subsequently, NCVET had also received a letter from Joint Secretary, MSDE endorsing the qualification.
- **7.2.** The Committee was further apprised that after scrutiny of the qualification as per the NSQF norms, the qualification was approved "on file" vide file no.

36003/04/2024/NCVET on 10.06.2024 on an urgent basis owing to the requirement of signing of AB agreement.

7.3. The Committee took note and ratified the agenda.

8. AGENDA ITEM 08: RATIFICATION OF ADOPTION OF ONE (01) MICRO CREDENTIAL BY HEALTHCARE SECTOR SKILL COUNCIL (HSSC)

8.1. The Committee was apprised that the Healthcare Sector Skill Council (HSSC) had submitted a request to adopt the micro-credential titled "Biomedical Waste Management-Nursing and Paramedical Staff," pegged at NSQF Level 4.5 with 30 Notional Hours developed by the Skill Council for Green Jobs (SCGJ). The HSSC was granted the awarding rights for the micro-credential vide File no. 27003/09/2017/NSDA-Part dated 14th May 2024.

8.2. The Committee took note and ratified the agenda.

9. AGENDA ITEM 09: RATIFICATION OF ADOPTION ONE (01) QUALIFICATION BY INFRASTRUCTURE EQUIPMENT SKILL COUNCIL (IESC).

9.1 The Committee was apprised that the Infrastructure Equipment Skill Council (IESC) has submitted a request to adopt a Qualification file titled "Grader Machine Operator," pegged at NSQF Level 3 with 420 Notional Hours developed by the Skill Council for Mining Sector (SCMS). Subsequently, the IESC has been granted the awarding rights for the Qualification through an 'on-file approval' process (File no. 21001/2/2017/NSDA dated 11th May 2024).

9.2 The Committee took note and ratified the qualification.

10. AGENDA ITEM 10: RATIFICATION OF ONE (01) RECEIVED FROM QUALIFICATION RECEIVED FROM DELHI METRO RAIL ACADEMY.

10.1. The Committee was apprised that DMRA had been granted provisional recognition as an Awarding Body (Dual) and had submitted one (1) qualification named "Customer Relation Assistant (Metro Railways)" pegged at NSQF Level 4 with 360 Notional Hour for approval. Subsequently, after scrutiny of the qualification as per the NSQF norms, the qualification was approved "on file" vide F.No. 36003/08/2024/NCVET on an urgent basis owing to the requirement of signing of agreement.

10.2. The Committee took note and ratified the qualification.

11. AGENDA ITEM 11: RATIFICATION OF ONE (01) MICRO CREDENTIAL (RETAIL SECTOR) RECEIVED FROM OPEN NETWORK FOR DIGITAL COMMERCE (ONDC)

- 11.1. The Committee was apprised that Open Network for Digital Commerce (ONDC) had been granted provisional recognition as an Awarding Body (Dual) and ONDC had submitted 1 Micro Credential (MC) namely "Basics of Digital Commerce for Open Network" pegged at NSQF Level 2.5 with 7.5 Notional Hours for approval. ONDC had submitted a request for urgent approval of the Micro Credential for early and immediate roll out of the MC to ensure that the learners enrolled in the course can be accorded due credits.
- **11.2.** The Committee was further apprised that keeping in view of the urgency to accord due credits to learners enrolled in the Micro Credential and the requirement of agreement signing with NCVET, the Micro Credential was reviewed in accordance with the NSQF norms and was granted 'on file' approval vide file no. 36003/23/2024/NCVET dated 15th July 2024.

11.3. The Committee took note and ratified the qualification.

12. AGENDA ITEM 12: EXTENSION OF VALIDITY OF TWO QUALIFICATIONS OF WATER MANAGEMENT & PLUMBING SKILL COUNCIL (WMPSC)

- 12.1. The Committee was informed that WMPSC requested for an extension of validity for the qualifications Plumber General (PSC/Q0104) pegged at NSQF Level 3 with 360 Notional Hours and Assistant Plumber General (PSC/Q0102) pegged at NSQF Level 4 with 450 Notional Hours via email on 08/07/2024, as they expired on 27th May 2024. The justification provided by WMPSC for not submitting the qualifications for revision before their expiry was deemed unsatisfactory. However, NCVET found that these qualifications are critical for various government schemes, including the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Corporate Social Responsibility (CSR) trainings, and state-led initiatives like the Uttar Pradesh Skill Development Mission (UPSDM), Himachal Pradesh Kaushal Vikas Nigam (HPKVN), Andhra Pradesh State Skill Development Corporation (APSSDC), and Assam Skill Development Mission (ASDM). Extending their validity is essential for WMPSC to continue providing necessary training, supporting these crucial programs.
- 12.2. The Committee was apprised that, given the above considerations, the validity of both qualifications may be extended for an additional period of six months from the date of expiry, i.e., until 27th November 2024. This extension will provide WMPSC the necessary time to submit the revised qualifications for NSQC approval.

- 12.3. The Committee approved the agenda. The Committee emphasized that no future extensions for qualification validity will be permitted. It was emphasized that action on qualifications pending revision and should be addressed promptly prior to their expiry date on the National Qualifications Register (NQR).
- 12.4. The Committee further suggested that a mechanism to identify the qualifications nearing expiration and suitably taking the necessary action for renewal be developed and followed by all ABs.

13. AGENDA ITEM 13: EXTENSION OF VALIDITY OF ONE (01) QUALIFICATION OF SECTOR SKILL COUNCIL FOR FOOD PROCESSING (FICSI)

- 13.1. The Committee was apprised that a qualification from the Sector Skill Council for Food Processing (FICSI) namely "Jam, Jelly and Ketchup Processing Technician" (NQR CODE-2022/FI/FICSI/06690) pegged at NSQF Level 3 with 300 Notional Hours was approved in the 10th NSQC Meeting on 29th July 2021, with its validity expiring on July 29, 2024, and due for revision. FICSI reported they were in the process of revising and rationalizing this qualification to include electives. However, the qualification was still being implemented under various government schemes, including PMKVY, PMKUVA 2022, and the DDUGKY program, across several states such as Assam, Uttar Pradesh, Tamil Nadu, Meghalaya, Manipur, West Bengal, and Uttarakhand. As a result, FICSI requested a three-month extension to ensure the continuation of existing training and further certifications by providing the details of training conducted over the past three years (2125), along with pending assessments for ongoing batches (419).
- 13.2. The Committee was further informed that, in light of the request and justification provided, the mentioned qualification was granted a one-time extension of validity until 29th October 2024. It was advised that the AB should ensure no new enrollments occur and that this extension is solely for completing assessments and certifications of already enrolled batches. The qualification would be archived after the validity period ends on 29th October 2024.
- 13.3. The Committee took note of the status and directed that the revised qualification be submitted at the earliest and granted a three-month extension for the ongoing batch.
- 13.4. The Committee further directed that ABs/SSCs maintain a vigilant watch on qualification structures and undertake necessary rationalization processes, and no further extensions will be considered thereof.

14. AGENDA ITEM 14: APPROVAL OF CERTIFICATION MECHANISM FOR INDIASKILLS COMPETITION 2024

- 14.1. The Committee was apprised that, as per Order No. 32001/06/2023/NCVET dated 26.01.2024, the skills showcased in the IndiaSkills Competitions 2024 were meticulously aligned with the National Skills Qualification Framework (NSQF). The IndiaSkills competition was made more aspirational, allowing participants to earn NSQF-aligned certificates and credits as per the NCrF, thereby creditising their learning outcomes.
- 14.2. The Committee was further apprised that the IndiaSkills2024 competition concluded at District, State, and National levels, with skill competitors assessed at multiple stages. It was observed that there was a significant variation in the marks obtained across various trades, with scores ranging from 0.54 to 99.67, according to the NSDC portal database. As a result, various stakeholders requested that NCVET suggest a mechanism for ascertaining successful assessment and certification for candidates.
- 14.3. The Committee was further apprised that a meeting was held on 21st June 2024 between NCVET, NSDC, and Awarding Bodies to discuss the certification and credit issuance mechanism. NSDC noted that due to time constraints, the Pre-national competitions were not conducted, and candidates from the State competitions directly participated in the National competition. It was decided that participants who showcased high competency levels at the National, State, and District levels would receive certification and credits based on their assessments. The successful clearing of assessments at preceding levels would form the basis for issuing certificates and credits. The certificate and credit allocation mechanism agreed upon during the meeting was outlined as follows:

- 14.4. The Committee was further apprised that NSDC would make provisions on the SIDH portal for the issuance of such certificates. Additionally, NCVET will issue a Standard Operating Procedure (SOP) for the assessment, certification, and creditisation of subsequent India Skills competitions, in consultation with MSDE, NSDC, Awarding Bodies, and other stakeholders.
- 14.5. The Committee took note of the status and approved the agenda.

15. AGENDA ITEM 15: APPLICABILITY OF NOTIONAL HOURS OF EMPLOYABILITY SKILLS (ES) FOR NSQF ALIGNED AND APPROVED QUALIFICATIONS OF THE SKILL COUNCIL FOR PERSONS WITH DISABILITY (SCPWD)

- **15.1.** The Committee was apprised that NSQC in its 20th Meeting held on 30th June 2022 had approved Employability Skills (ES) NOS and further instructed all Awarding Bodies to include ES as mandatory component in all NSQF aligned and approved qualifications.
- **15.2.** To accommodate the ES NOS requirement for various NSQF levels, 4 variants of ES NOSs, i.e., 30Hrs, 60Hrs, 90Hrs and 120Hrs have been developed and approved by the NSQC. Accordingly, all the existing NSQF aligned qualifications are being rationalized for inclusion of an appropriate ES NOS.
- **15.3.** Further, to address the unique needs of Divyangjans, Department of Empowerment of Persons with Disabilities (DEPwD) along with SCPwD has developed a customized 70 Hour ES Module, instead of the existing 60 Hour ES Module for inclusion in all NSQF aligned qualifications developed for PwDs to cater to their specific expository based requirement and ensuring better outreach and accessibility. NSQC, in its 37th Meeting held on 30th April 2024, approved the said ES NOS or 70-Hour Employability Skills (ES) submitted by Skill Council for Persons with Disability (SCPwD). The Committee had also approved the inclusion of this NOS in all NSQF-aligned qualifications pertaining to the Persons with Disability (PwD) sector.
- **15.4.** Replacement of this 70 Hour NOS with the ES NOS existing in the earlier qualification would result in modification of total notional hours of the qualification. The details of all qualifications with modified notional hours are placed as Annexure III Based on the above, SCPwD may be allowed to carry out changes in their existing qualifications without changing the version and submit the same to NCVET for approval at the Director's level. This 70-Hour ES module will carry the credit equivalence of a 60-Hour Module, i.e., 2 Credits since the additional hours only caters to the specific requirement of Persons with Disabilities.



15.5. The Committee was further apprised that once the verification and approval are completed, the list of qualifications will be brought before the NSQC for information and ratification.

15.6. The Committee took note of the status and approved the agenda.

16. AGENDA ITEM 16: ADOPTION OF NSQF ALIGNED QUALIFICATIONS BY INDIAN DEFENCE FORCES

- **16.1.** The Committee was apprised that during the 31st Meeting of the NSQC, it was discussed that a considerable number of NSQF-aligned and approved qualifications are common and applicable across Defence Forces, with or without minor modifications. Therefore, Defence Awarding Bodies may adopt such qualifications as per the NCVET Guidelines for Adoption of Qualifications by Awarding Bodies. However, for better coordination, record-keeping, and effective execution & implementation, it was decided on the request proposed by Indian Army Awarding Bodies be sent to Army Training Command (ARTRAC) that a consolidated list of all such qualifications proposed for adoption by the ARTRAC.
- **16.2.** The Committee was further apprised that a consolidated list, duly vetted by ARTRAC, would then be placed before NSQC for grant of approval. Modifications, if required, may also be undertaken in the adopted qualifications, subject to adherence to the parameters outlined in the Guidelines for Adoption of Qualifications. Subsequently, ARTRAC shared a list of 22 qualifications proposed for adoption by five Directorates of the Indian Army (Awarding Bodies).

17. AGENDA ITEM 17: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT & APPROVAL

- 17.1. The Committee was apprised that a total of 200 Qualifications/NOSs/MCs (comprising 55 New and 64 Revised qualifications, 58 NOSs, and 23 MCs) were placed for the consideration of the NSQC.
- 17.2. Subsequently, 80 Qualifications/NOSs/MCs (Comprising 21 New and 14 Revised qualifications, 41 NOSs and 4 MCs) were discussed in the Phase-I of the 39th NSQC Meeting, out of which 60 Qualifications/NOSs/MCs (comprising 8 New and 11 Revised Qualifications, 40 NOSs and 1 MC) were approved and 2 Qualifications were not approved.
- 17.3. The Committee further directed that out of the 80 Qualifications/NOSs/MCs 39th Phase 1 the NSQC 18 presented during the of Meeting, Qualifications/NOSs/MCs (comprising 11 New and 3 Revised qualifications, 1 NOS and 3 MCs) to be placed again for discussion in the phase II of the 39th NSQC Meeting. Accordingly, the balance 138 Qualifications/NOSs/MCs will be considered for discussion in the subsequent NSQC Meeting, i.e., the 39th NSQC (Phase-II).
- 17.4. The detailed status of approval and the Committee's decisions are provided in Annexure II, which includes qualifications from Central Ministries, State Bodies, Sector Skill Councils (SSCs), and other government and private bodies.
- **17.5.** The detailed status of the Qualifications received is in the succeeding paras:
 - **17.2.1. Directorate General of Training (DGT) (Automotive) -** Two (02) Qualifications were presented before the Committee and approved.
 - 17.2.2. Directorate General of Training (DGT) (IT-ITeS) One (01) Qualification, one (01) MicroCredential and three (03) NOSs were presented before the Committee. The Micro-credentials and the NOSs were approved and the

qualification was conditionally approved subject to the updation of the Trainer qualification details in the Q-File.

- 17.2.3. Directorate General of Training (DGT) (Capital Goods) Five (05) new NOSs and seven (07) revised Qualifications were presented before the committee and were approved.
- **17.2.4. Directorate General of Training (DGT) (Plumbing)** One (01) revised Qualification was presented before the committee and was approved
- **17.2.5. Directorate General of Training (DGT) (Electronics)** Two (02) new NOSs were presented before the committee and were approved
- 17.2.6. National Institute of Electronic and Information Technology (NIELIT) -Twenty-Seven (27) new NOSs and two (02) revised Qualifications were presented before the committee and were approved.
- 17.2.7. RUDSETI (BFSI) Two (02) qualifications, (1 Revised qualification and 1 New NOS) were presented before the committee. One (01) revised qualification and 01 new NOS were approved. However, it was directed to check if there is any existing qualification similar to the revised qualification "Assistant Bookkeeper" submitted by RUDSETI.
- 17.2.8. RUDSETI (Beauty and Wellness) One (01) new qualification "Junior Beauty Practioner (Laghu Udyami)" was not approved due to duplicity aspect raised by Beauty and Wellness Sector Skill Council. The Committee directed RUDSETI to rework on removing duplicity in the qualification.
- **17.2.9. Footwear Design and Development (FDDI, Noida)** One (01) New qualification pertaining to leather sector was presented before the Committee and was approved.
- 17.2.10. West Bengal State Council of Technical & Vocational Education and Skill Development (WBSCTVESD) - One (01) New qualification pertaining to the Electronics sector was presented before the Committee and was approved. One (01) new qualification "Assistant Beautician" was not approved due to duplicity aspect raise by Beauty and Wellness Sector Skill Council. The Committee directed WBSCTVESD to rework on removing duplicity in the qualification.



- 17.2.11. Beauty and Wellness Sector Skill Council One (01) qualification and two(02) NOSs were presented before the Committee and the same were approved.
- **17.2.12. Leather SSC** Four (04) New and Two (02) Revised qualification were presented before the committee. However, the committee directed to submit data on number of trainings conducted in revised qualifications and the changes done in the NOSs of the revised qualification. For the new qualifications the AB is to submit the proposed number of trainings.
- 17.2.13. Management and Entrepreneurship & Professional Skill Council Four (04) New Qualifications and Two (02) New Micro-Credentials were presented before the committee. Only two Qualifications namely "Digital Sales and Marketing Executive" and "Advance Course on Digital Sales and Marketing' were approved.
- **17.2.14. Divya Yog Mandir Trust (Patanjali)** One (01) new Qualification was presented before the Committee and was approved.
