HIGHLIGHTS

About

National Institute of Electronics and Information Technology (NIELIT), is an autonomous scientific society under the administrative control of Ministry of Electronics and Information Technology (MeitY), Government of India. NIELIT is actively engaged in Capacity Building and Skill Development in the areas of Information Technology (IT); Electronics; Communication Technologies; Hardware; Cyber Law; Cyber Security; IPR; GIS; Cloud Computing; ESDM; e-Waste; IoT; e-Governance and related verticals. It offers courses both in the Formal as well as the Non-Formal sectors and is also one of the National Examination Bodies which accredits institutes/ organizations for the conduct of courses in the Non-Formal Sector. NIELIT is also the preferred agency for many State Governments for rolling out IT Literacy Programmes for its employees and the masses.

NIELIT is functioning under the overall control and guidance of the **Governing Council**. The Hon'ble Union Minister for Electronics and Information Technology (E&IT) is the Chairperson of the Council whereas Hon'ble MoS (E&IT) is the Deputy Chairperson. Other members of the Council are from Government, Industry, Academia and representatives of various professional bodies.

The **Management Board** of NIELIT is chaired by the Secretary, Ministry of Electronics and Information Technology (MeitY), Government of India. Each NIELIT Centre has an **Executive Committee** consisting of representatives from respective State Governments, academic institutions and industry for the effective implementation of the decisions of the Board and the Council.

The **Finance & Accounts (F&A) Committee** of NIELIT is chaired by the Director General, NIELIT and the Committee assists the Governing Council by recommending the Budget Estimates / Revised Estimates and other finance related matters. The Committee is also mandated to scrutinize the Audited Annual Accounts before its submission to the Governing Council for adoption, besides appointment of Auditors. The day to day activities of NIELIT are managed by the Director General.

The vigilance department of NIELIT is headed by **Chief Vigilance Officer (CVO)**, a senior officer from MeitY. The CVO is assisted by a Vigilance Officer at each Centre and also at NIELIT Headquarters. The vigilance activities of NIELIT include the preventive measures which are required to create a healthy and transparent working environment.

In order to promote transparency and accountability, mandatory provisions of the Right to Information Act (RTI) have been implemented in the Institute with effect from July 2005. The **Public Information Officer (PIO)** at Headquarters, as well as, PIOs at all NIELIT Centres have been appointed, as per the requirement spelled out under RTI Act. To deal with the requests under RTI Act, internal procedures have been formulated and the mandatory information has been hosted on the NIELIT website (WWW.NIELIT.GOV.IN). In addition, a Transparency Officer has also been appointed in the organisation as per the requirement of RTI Act. With a view to bring excellence in public service delivery and to redress grievances of citizens in a meaningful manner, NIELIT has also appointed a **Public Grievance Officer (PGO)**, in line with the guidelines promulgated by Department of Administrative Reforms & Public Grievances. The statutory instructions for use of Hindi are being complied in accordance with region wise locations of NIELIT Centres.

NIELIT has established itself as a premier organization having pan-India presence through a network of **40 own Centres** at Agartala, Aizwal, Ajmer (Kekri), Alawalpur, Aurangabad, Ayodhya, Bhubaneshwar, Calicut, Chandigarh,





Chuchuyimlang, Churachandpur, Chennai, Delhi, Dibrugarh, Gangtok, Gorakhpur, Guwahati, Haridwar, Imphal, Itanagar, Jammu, Jorhat, Kohima, Kokrajhar, Kolkata, Kurukshetra, Leh, Lucknow, Lunglei, Pali, Pasighat, Patna, Ranchi, Ropar, Senapati, Shillong, Shimla, Silchar, Srinagar, Tezpur and Tura, with its Head quarters at New Delhi. It is also well networked throughout and a network of about **747+ accredited training institutions** for training of O/A/B/C level courses, besides a network of about **9444+ facilitation centres** engaged in training of digital literacy courses.

Skill Development and Capacity Building

Skills development is crucial for stimulating a sustainable development process and can make a contribution to facilitate the transition from the informal to the formal economy. The principles and values of decent work provide guidance for the design and delivery of skills development and are an effective way of efficiently managing socially just transitions. The National Policy on Skill Development is aimed towards empowering all individuals through improved skills, knowledge and nationally and internationally recognized qualifications to gain access to decent employment and to ensure India's competitiveness in the global market. NIELIT plays an important role for skilling of youth in the area of IECT, especially in rural sectors. The wide repertoire of NIELIT Courses includes: (a) Courses in the **Formal Sector** offered by the NIELIT Centres in association with State Universities/Technical Board such as **ME/ M.Tech, BE/B.Tech, MCA, BCA** programmes; Aurangabad Centre is also conducting **PhD Program** in the area of Electronics(b) Courses in the **Non Formal Sector** in IT, Hardware, Bio-informatics etc., under four levels, namely **'O'** (Foundation); **'A'** (Advance Diploma); **'B'** (MCA equivalent); and **'C'**

(M.Tech equivalent); **Short Term Courses** in niche areas; and **IT Literacy Programmes** for the proliferation of Digital Literacy in the country; besides specialized programmes in e-Governance targeted towards empowering the employees of the State Governments. In addition, NIELIT has also created expertise for the roll out of customized skill development programmes, as per specific needs of public and private sector firms.

Since 2012, efforts have been made to broaden the scope of courses being offered by NIELIT with the primary objective of empowering the rural youth and enhancing their livelihood in line with 'Digital India', 'Make in India' and 'Skill India' mission of Government of India. Emphasis has been made to ensure that any new course developed by NIELIT is in sync with industry requirements so that students undergoing training under these courses can be readily absorbed in the industry. It is pertinent to mention that NIELIT courses are categorized as Formal Sector and Non-Formal Sector courses. Under Non-Formal Sector courses, the NIELIT Centre also offers standardized short term courses besides long-term national level courses such as O, A, B, and C levels of courses. In order to ensure that NIELIT Courses are up to date and aligned with industry requirements, pro-active measures are being taken to align these courses with government regulations and framework. The O and A level courses have been aligned with the National Vocational Educational Qualification Framework (NVEQF) promulgated by AICTE and subsequent to subsuming of NVEQF with National Skills Qualifications Framework (NSQF), NIELIT is amongst the front-runners that has aligned 51 courses with NSQF.







Diversification of Courses

Repertoire of NIELIT Courses has been **diversified** to a greater extent to embrace latest technological trends. Through diversification efforts have been made to tap technological potentials in emerging areas for promotion of Skill Development. The outlook of NIELIT has been streamlined to cater to the needs of rapidly changing environment taking into account the fast rate of obsolescence in the area of Electronics and Information Technology. The mushrooming of Private Computer Engineering Colleges has adversely affected the number of candidates opting of long term non formal courses in IT such as O/A Levels, which has necessitated diversification of activities in the area of Skill Development and Capacity Building. This has resulted admission to Short-term courses and revenue at a faster space. A thrust was given on a course which can enhance employability. The activities of NIELIT have also been substantially diversified in line with its aim and objectives and the same has fetched additional revenues besides brand building. Through diversification NIELIT has carved a niche name as a preferred capacity building organization for implementation of projects at State and National Levels.

Process Re-engineering

Re-engineering of legacy systems and processes was a daunting task, which has been achieved in NIELIT resulting in dramatic improvements in critical and contemporary measures of performance, such as cost, quality, services and speed. The process re-engineering or improvements are more than just tweaking to do things 'a bit better' or responding to a specific problem or event, it has been about systematic analyzing, identifying and evaluating options and solving challenges to make a significant difference. Much of its focus has been on removing non-value adding activities and costs and improving the efficiency and effectiveness of processes. The process reengineering initiatives that NIELIT has adopted has resulted in stupendous growth – a feat that can be rarely matched by other similar organizations.

Using Technology as a Force Multiplier

NIELIT has effectively **put technology to use** to facilitate stakeholders and also inculcate greater transparency and accountability in the process. The proactive use of technology in all spheres has resulted into stakeholder confidence in respect of delivery of services in a timely, efficient and transparent manner. Moreover, collection of fees through Online processes has resulted into proper monitoring of the funds. The adoption of technology by NIELIT has facilitated training institutes to apply online for accreditation/facilitation from the comfort of their homes/offices thereby making services available to them 24X7. Biometric attendance (since Jan, 2014) has resulted in a marked improvement in employee discipline and punctuality. Better visibility through an improved/revamped website has resulted into better marketability of NIELIT courses. In general, the outcome of technology adoption has resulted in ease of use, accessibility of all concerned propelling the growth of NIELIT.

Synergy through Collaborations and MoUs

The futuristic vision has resulted in expansion of activities and creation of synergy with leading agencies. Efforts to create a "win-win" situation where collaborations have been made purely on non-exclusive and non-financial basis has provided an enabling framework for embracing specialized technology and better employment opportunities for NIELIT students. Some of the major collaborations and MoUs are as follows:

1. Monster.com India Pvt. Limited - to collaborate with each other or jointly collaborate with the third parties for increasing employability, assisting placement and/or facilitating job search/opportunities for the persons trained under various skills and vocational training initiatives of NIELIT. (April 25, 2016)



- 2. Amazon Internet Services Private Limited (AISPL) The MoU will facilitate availability of the Amazon Web Services Educate program to NIELIT and its Centres for its candidates enrolled in various certificate/degree courses. The non exclusive MoU is aimed at creation of synergy, whereby about 25K students of NIELIT would be encouraged to access online services and contents, free of cost from Amazon Cloud Servers. (June 29, 2016)
- 3. IIT Ropar to foster collaboration, provide opportunity for global experience and to facilitate the advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interaction. (March 6, 2017)
- 4. Indian Institute of Public Administration (IIPA) to synergize common efforts through training program in e-Governance. (April 3, 2017)
- 5. Google Inc. master training of NIELIT trainers on Android (May 19, 2017)

6. AICTE – NIELIT signed a MoU with AICTE under Employability Enhancement Training Programme (EETP). The MoU is aimed to produce engineering graduates adequately equipped with required skills to achieve the highest personal and professional standards by means of intensive hands-on training to ensure that their technical skills are globally acceptable. (June 22, 2017)

International Co-operations and Global Exhibitions

At the international arena the capacity building activities of NIELIT have been highlighted through proactive participation in bilateral meetings and industry visits that has resulted in greater prominence of NIELIT in reputed countries around the world. Some of these initiatives are as follows:

- 8th International IT Forum, Russia: NIELIT participated in the 8th International IT Forum with participation of BRICS and SCO at Khanty-Mansisysk, Ugra, Russia. NIELIT officer deliberated on the topic, business cooperation between India and Ugra and also briefed the member about the role of NIELIT in Digital India initiatives of the Government of India. The possibility of conduct of Joint training programmes between NIELIT and Ugra Research institute of Information Technology (URIIT) was also discussed. (June 8-9, 2016)
- 2. **HASS, Sudan:** A delegation of 45 participants from Higher Academy for Security Studies (HASS) under the Sudanese Ministry for Higher Education and Scientific Research interacted with NIELIT Team lead by Dr. Ashwini Kumar Sharma, Director General who brought out the capacity building and skill development initiatives of NIELIT and highlighted the 'Skill India', 'Make in India' and 'Digital India' initiatives which are prestigious flagship programme of Government of India. The interaction programme served as a platform to explore the technical education system in both the regions. (April 12, 2016)
- 3. Innoprom, Russia: NIELIT participated in Innoprom 2016, one of the at Yekatrinborg, Russia the largest industrial fair that provide direct contacts with the global and Russian producers. In Innoprom 2016 India was awarded the status of 'Partner Country' and the exhibition was also attended by Hon'ble Union Minister of State (IC), Commerce and Industry, besides the Hon'ble Chief Ministers of Maharashtra, Rajasthan and Andhra Pradesh. The event provided a platform for greater publicity and marketing at the international level in respect of NIELIT Courses and activities. (July 11-14, 2016)
- 4. Colombian Ministry of ICT: To explore possibilities of joint initiatives between NIELIT and Colombian





counterparts a meeting with officials of Colombian Ministry of ICT was held at NIELIT HQ though Video Conferencing. The meeting was chaired by Dr. Ashwini Kumar Sharma, Director General from the India side and Ms. Jaifa Mezher, Head of international office at Ministry of ICT from the Colombian side. Subsequent to the meeting Dr. Ashwini Kumar Sharma also attended the meeting with Ambassador of Colombia at India on August 01, 2016. With regard to the discussions held the Hon'ble Minister of ICT, Republic of Colombia has send a formal invite to Director General and NIELIT officials to visit Colombia so that mechanism for increased cooperation in IT including capacity building, skilling and trade promotion initiatives can be worked out. (July 29, 2016)

- 5. **Mezonru Group of Companies, St. Petersburg:** As a result of deliberations held during Innoprom 2016 at Yekatrinborg, Russia meeting was held with Mr. Pavel Frolo, CEO, Mezonru Group of Companies at NIELIT HQ to explore the possibilities of developing courses in Robotics and IoT. During the meeting a live demonstration on Robotic applications was also organized and the possibility of introducing courses on Robotics for various age groups was explored. (November 25, 2016)
- 6. 4th India-Japan Joint Working Group (JWG) at Japan: Dr. Ashwini Kumar Sharma, Director General, NIELIT led the Indian delegation at the 4th India-Japan Joint Working Group (JWG) at Tokyo and Kyoto. Extensive deliberations to support and promote the Make-In-India initiative of the Government of India were held during 'Industry-to-Industry' and Industry-to-Government' sessions at the meet. Director General, also discussed skill development initiatives with the Japanese delegation led by Mr Yoshiaki Takeuchi, DDG, IT Strategy, Communications & Information Policy Bureau, Japan, besides, discussions were also held with leading manufacturer and supplier of electronics components to explore the possibility of skilling by NIELIT to facilitate Japanese companies setting base in India. (November 28-December 2, 2016)
- 7. As a part of capacity building project funded by MeitY, NIELIT had sent a team of 05 Officers to Taiwan for a 45-day Practical Hands-on for Mobile Handest Design Engineers to promote 'Make-in-India'. The training was conducted at International Trade Institute, Ministry of Economic Affairs, Hsinchu, Taiwan in collaboration with Ministry of Electronics & IT(MeitY), India Cellular Association(ICA) and Mediatek.

Building Construction of NIELIT Campuses

With a vision to provide an excellent infrastructure with residential facilities for the benefit of the students from far flung areas, Ministry of Electronics & Information Technology (MeitY), Government of India has approved the setting up of permanent campuses of NIELIT Centres in different parts of the country. Apart from MeitY approved projects for NIELIT Centres, NIELIT has also constructed its headquarters building with its own corpus. With the continuous efforts and rigorous follow up with the stake holders, the building projects which were either stalled/or running very slow due to one or other reason such as non-allotment of land, old cost-estimate index, encroachment, clearance from local authorities etc, were streamlined and have been successfully executed. The new Centres have helped in expanding the NIELIT's reach to the remote areas where other institutes of good repute are not present in the areas of Electronics & Information Technology. The list of building projects is as follows:



1. NIELIT Headquarter's building at Dwarka, New Delhi – NIELIT Headquarters was allotted a land in 2002 at Dwarka, New Delhi and the construction work was awarded to CPWD in 2007. However, construction could not be taken up till 2012. Dr. Sharma was instrumental in taking forward this long pending issue and after rigorous follow up with DDA & CPWD, all approvals and clearances were obtained and the construction was started in 2015. The building was inaugurated by Shri Ravi Shankar Prasad, Hon'ble Union Minister (E&IT, L&J) and Shri P.P. Chaudhary, Hon'ble Union MoS (E&IT, L&J) on May 06, 2017.



2. NIELIT Agartala – The project was approved by MeitY in March 2008 however the project cost was revised in January 2013. After the cost revision the construction was taken up and the building got ready. The Centre has started operations in new building since January 2016. The building was dedicated to the Nation for IECT related Skill Development and Capacity Building Activities by Shri P.P. Chaudhary, Hon'ble Union MoS (E&IT, L&J) on April 26, 2017



3. **NIELIT Kolkata** – The project was approved by MeitY in February 2009, however, due to various reasons such as court case, cost revision etc, the construction of building could be started in July 2013. The building is now complete and ready for inauguration.

4. **NIELIT Patna –** The project was approved in October 2012 and the cost was revised in December 2014. There were many challenges like encroachment issue etc. However, now the construction is in progress and is likely to be completed by July 2017.



5. **NIELIT Ajmer –** The project was approved in October 2010 however the project cost was revised in March 2013. The construction of the building was taken up through Central CPSU and the building got completed 2015. The Centre has started operations in new building since December 2015.



6. **NIELIT Ropar** – The project was approved by MeitY in January 2014. After rigorous follow up, Change of Land Use (CLU) was obtained from State Government and the construction was taken up with Central PSU. The construction of building started in June 2015 and the building is now ready for inauguration. The approach road to the land is yet to be constructed by State Government for which matter is being taken up with State Government.







7. **Construction/upgradation of permanent campuses in North East:** In North East, 18 campuses were approved by Hon'ble Cabinet in 2012, whereas, land was available at only one location (Imphal) that time. Rigorous follow up was done with respective State Governments and NIELIT has been able to obtain land for new campus/upgradation at 15 locations out of 18. Construction has started at 12 locations (Imphal, Senapati & Churachandpur in Manipur; Aizawl & Lunglei in Mizoram; Chuchuyimlang in Nagaland; Shillong in Meghalaya; Pasighat in Arunachal Pradesh; Tejpur, Kokrajhar, Jorhat, Dibrugarh in Assam) and at three more locations (Guwahati in Assam, Tura in Meghalaya & Gangtok in Sikkim) it is likely to start soon.

Digital Payment Initiatives

NIELIT has developed institutionalized mechanism by putting technology into use for making payments in the Digital Mode in respect of the following activities connected with Payments and Receipts. Post demonetization NIELIT through its own Centres and Training Partners is imparting training on digital payments to students, citizens and merchants. Since demonetization it has skilled about 1.4 Lakh citizens on usage digital payments. At the national level, it is also organizing Workshops and Camps (DigiDhan Mela) at more than 135 locations in India to train and on-board small and medium enterprises / traders on digital payment initiatives.



Through these initiatives about 13,500 traders are being targeted. NIELIT is actively promoting Government of India's initiative of moving towards a less-cash economy through its Social Media handles. NIELIT has endeavored to covert legacy system of receipts and payments in cash, since 2014, to an Online, transparent and accountable system through digital means. As a result, the organization has also reaped its benefits in terms of - *cost reductions; minimization of overdue payments; simplification of dispute management; increase in compliance; enhancement in security; and improvement in workflow efficiencies.* The internal initiatives at NIELIT related to digital payments and receipts are as follows:

- 1. **Payment to Vendors and Suppliers:** All payment to Vendors and Suppliers are being made only through NEFT/RTGS and in the last two years it has been ensured that all such payments are made only in the digital mode directly to the bank account of the beneficiary. Use of Cash as a mode for making payment to vendors/suppliers has been discontinued since 2014. About 7,000 online transactions have been processed for a value of about Rs.325.08 crore during the last financial year.
- 2. Salary of NIELIT officials: The salary of all officials in NIELIT including contractual staff are transferred directly to their Bank Accounts and the said system is in place since 2007. Also for reimbursement of expenses such as Medical, TA/DA, Conveyance, Newspaper Allowance/Children Education Allowance etc, the same are provided in the Online mode and no cash reimbursement are now admissible to the employees. NIELIT also provides SMS alert to the employees as and when any payment are transferred to their bank account.
- 3. Payment to Experts/ Stakeholders: NIELIT utilises the services of experts for conduct of examination,





including evaluation of answer scripts, paper setting, screening visits etc. and all such payments to experts and stake-holders are being made through NEFT/RTGS directly to their bank accounts since 2014.

- 4. Advance issued to employees and settlements thereof: Any advance being issued to employees is done only through Cheques and the system is being further improved to so that the advance once approved are directly transferred to the bank account of concerned employee in the Online mode. Similarly, settlements of advances are also accepted only through Cheques.
- 5. **Government e-Marketplace (GeM)** efforts are being made to ensure that items such as Furniture/ Fixtures/ Equipments, etc are procured through Government e-Marketplace (GeM) portal and payments thereof are also made in the Online mode.
- 6. **Scholarship through DBT –** *NIELIT provides Scholarship to EWS/Female/Physically Disabled candidates and all such scholarship payments are being made only through Aadhar Based Direct Benefit Transfer (DBT) since 2015. About 2500 transactions have already been done.*
- 7. **Statutory Payments –** all statutory payments like EPF/Service Tax/Income Tax etc. are being filed only in the Online mode through the designated portals.
- 8. **Petty Cash** requirements such as petrol/diesel, purchase of small items etc. is being done away with through pre-loaded Bank Cards.
- 9. Online Payment Gateway NEILIT CCC/BCC examinations are conducted only in the Online mode and all related activities such as payment of fees by students, issue of admit cards, issue of e-Certificate linked with Digital Locker, etc, are also being made in the Online mode. Students can submit their fees either by Credit Card/Debit Card/ Net Banking through Payment Gateway directly at the NIELIT Portal or through NEFT/RTGS. Rural students can also avail the facility of designated CSC-SPV centres to transfer their fees in the Online mode. Fees in respect of classroom based examinations such as O/A/B/C Levels are also collected only in the Online mode.
- 10. Accreditation fees from training partners at present are being accepted through Bank Drafts and in this regard, a portal has been created to facilitate Training Partners, to submit the Accreditation Fees through online mode directly through the NIELIT portal.
- 11. **e-Procurement Portal** a system has also been put in place for accepting EMD in the Online mode. In this regard, it is pertinent to mention that at in line with Government directives, purchases are being made through e-Procurement Portal which provides a facility for submission of EMD amount in Online mode.
- 12. **SFMS** NIELIT has also initiated a process whereby Bank Guarantees can be provided through Structured Financial Messaging System (SFMS) in line with Government directives.

Digital Literacy

Digital Literacy is one of the vital components that every citizen needs to be equipped with to participate in a digitally enabled and progressive environment. The ambit of digital literacy comprise of numerous interrelated skills that range from basic awareness and training to highly sophisticated and more complex creative and critical literacy. Besides, employers also expect the prospective workforce to possess the skills to be productive straight away in a new role and believe that digital skills improve employee's efficiency and productivity. Taking into cognizance the need of hour, I have taken a holistic approach and the bouquet of Digital Literacy courses has been enhanced with 03 more courses and now the Digital Literacy courses of NIELIT comprise of courses of duration ranging from 36 hours to 200 hours. These courses have also been retrofitted with about 1.5 hrs module on





Financial Inclusion (developed by Department of Financial Services, MoF, GoI). The bouquet of Digital Literacy courses are elucidated as under:



The digital literacy courses of NIELIT, especially, BCC / CCC are accepted by the various State Governments / Government Departments such as Arunachal Pradesh, Bihar, Chandigarh, Daman & Diu, Gujarat, Maharashtra, Mizoram, Rajasthan, Sikkim, Tripura, Uttar Pradesh, O/o the CGA, DGE&T etc. for recruitment / in-service promotions/incentives etc.

To enable 24X7 learning, the e-Content of CCC course in 25 languages has been developed and made available at the website of NIELIT. As far as Classroom teaching is concerned the course is being delivered by more than 9000 Facilitation Centres throughout the Country. Besides, every month examination cycles of the courses are being held at more than 150 examination centres across the country. The course is governed by a complete online system i.e. registration of candidate for examination, receipt of examination fee, conduct of examination, declaration of results and issue of digitally signed e-Certificates. On an average more than 80,000 candidates appear for online examination cycle of digital literacy courses that are conducted on monthly basis.

Awards and Accolades

The performance of NIELIT has been appreciated at various forums, resulting in many accolades and awards. The Dalal Street Investment Journal (DSIJ), India's leading investment magazine has awarded NIELIT as most efficient growth enabler during 5th Public Sector Undertakings (PSUs) Awards 2013 held on April 2, 2014. Shri TKA Nair, the then Adviser to the then Hon'ble Prime Minister of India presented the award. NIELIT received recognition for its excellence of performance and the contribution towards capacity building in IT in the country. NIELIT was bestowed with the prestigious India Pride Award – 2016-17 for 'Excellence in India Image Enhancement' by the Dianik Bhaskar Group on



March 27, 2017. The award was received by Director General NIELIT from Shri Manoj Sinha, Hon'ble MoS I/C (Telecom) Hon'ble MoS, Railways, Government of India.





Notable Achievements

- In line with the guidelines issued by MeitY for promotion of mobile governance (m-Governance), NIELIT has launched 70 Mobile Apps on various topics of CCC course in 11 languages, so that the reach can be enhanced especially in rural areas, allowing rural students to access NIELIT courses through Smart Phones.
- In line with NIELIT's initiative to simplify procedures through process re-engineering, an Online Expert Empanelment System, for empanelment of experts in a transparent manner, was launched by Secretary, MeitY and Chairperson, Management Board, NIELIT.
- e-Contents developed in English for various NIELIT courses and the same are also being converted into Hindi and regional languages such as Tamil, Telugu, Bangla, Gujarati, Malayalam, Kannada, etc.
- Laid the foundation stone of the new Academic Block at NIELIT Imphal on April 22, 2016, followed by inauguration of Model Career Centre at Imphal.
- Model Career Centres have been established in Imphal, Leh and Kolkata with funding from Directorate General of Employment, Ministry of Labour & Employment, Gol, under National Career Services Scheme of Government of India. Job Fairs have been organised by Model Career Centres already established at Calicut, Gorakhpur, Aurangabad & Srinagar. In the last one year more than 15000 candidates have mobilized through 5 job fairs, out of which about 3000 candidates have been shortlisted for employment by more than 50 employers, who had also participated in the job fairs.





- NIELIT has conducted recruitment examination for the post of Scientist 'B' for MeitY/ STQC/ CERT-In. NIELIT has also processed recruitment for filling up of 94 posts of S&T and Non-S&T cadre for its Centres.
- Smart Classroom Project has been implemented by NIELIT Srinagar in about 640 schools under SSA/ RMSA Schemes of Government of J&K.
- Smart Virtual Classroom facility has been extended in additional 17 NIELIT Centres and thus the facility now
 exist almost all NIELIT Centres. The facility is being used extensively for conducting video conferencing for
 better coordination among NIELIT Centres and HQ and has resulted in saving of travelling time, money and
 also in efficient and faster decision making. The set up is also being used by the NIELIT Centres for conducting
 their training sessions in more professional effective way.







- In a unique initiative, a Study Centre has been established at Baramullah, J&K by NIELIT jointly with the Indian Army, from its own resources to mainstream local youth and women through skill development.
- NIELIT has made its foray in the domain of Social Media and in this regard the official twitter handle @NIELITIndia has been made operational with effect from May 24, 2016. Tweets are posted on daily basis and the official twitter handle of NIELIT is being followed by more than 5900 users. The tweets posted at the handle have also been retweeted by senior Government Officers, PIB, Cabinet Ministers and Hon'ble PM.
- NIELIT has been awarded a project on e-Waste management for Government Officials under Digital India by MeitY. In this regard, training of NIELIT Master Trainers has also been completed and training of Government Officers in 10 identified States is in progress.
- NIELIT as one of the authorized examination agency under NDLM (DISHA) is conducting examinations in the Online mode with biometric enabled Aadhaar authentication of candidates. So far, it has conducted examinations of about 8,35,932 candidates under the NDLM/DISHA scheme. On successful of examinations, candidates are also issued digitally signed certificates in the Online mode, which bears a QR code, so that the online certificates can also be verified in the Online mode.
- NIELIT has actively participated in the Vikas Parv Celebrations at 6 locations, namely Mumbai, Mathura, Jodhpur, Kakinada, Chindwara and Jamshedpur, led by Hon'ble MoE&IT and L&J to showcase Digital India initiatives and the achievements of the Government of India.



- Under the MeitY's Scheme on Skill Development in ESDM about 140268 candidates have been enrolled between 01.04.2016 and 31.12.2016 out of which 60261 candidates have been certified and 2936 candidates have been placed. Besides, four (4) Workshops have been conducted and four (4) MoUs have also been established with States.
- NIELIT has released scholarship to around 450 candidates from own resources on completion of O/A/B/C level IT Courses under the NIELIT's Scholarship Scheme for SC/ST/EWS/PH/ Female candidates. Sscholarship payments are being made through Aadhar Based Direct Benefit Transfer (DBT).
- Registrations in NIELIT O/A/B Level IT Courses have been increased significantly compared to the previous year. More than 7 lakh candidates have been registered in Digital Literacy Courses.
- Considering the manpower and infrastructure requirement in ESDM sector, NIELIT Calicut launched All India Post Graduate Diploma programme in various verticals such as VLSI and Embedded Hardware Design, One ASIC Design and Verification, and Embedded – Real Time Systems. These courses are being offered at NIELIT Centres, and are also being extended to Institutions/ Deemed Universities/ Organizations, who are meeting the criteria on required infrastructure.

 An Internet of Things (IoT) Lab has been established at NIELIT Calicut, which is equipped with Intel Galileo Boards and ARM Cortex Microcontroller Boards with the support of Intel India. The Post Graduate Diploma in IoT (6 Months) is presently being offered by NIELIT.

- NIELIT Lucknow has conducted Digital Marketing Course for 'Chikankari' workers / local artisans etc. to empower them to market their products in the Online mode through e-Commerce portals.
- NIELIT Aurangabad started a Doctorate (PhD) Programme in Engineering and Technology. About 80 Scholars have already been registered.
- NIELIT has been assigned the responsibility of the project titled "On-boarding of self-organised Small and Medium Businesses/Traders on Digital Payment Initiatives" by MeitY. In this regard, the nation-wide campaign was launched and inaugurated by Shri Ravi Shankar Prasad, Hon'ble Union Minter (E&IT, L&J) on MARCH 4, 2017. Under the project 35 workshops and 100 Digidhan camps are being organized by NIELIT all over the India.
- NIELIT has taken an initiative #Cycle2Work for motivating employees to ride a bicycle for commuting to office once a week at least, which is in line with the clarion call made by Hon'ble Prime Minister, Shri Narendra Modi in 'Mann Ki Baat' stating that Government officials should prioritize taking care of their health for better productivity at work and cycling to work at least once in a week could be one of the steps in this direction. 





Emphasis of Matter



The NIELIT, an Autonomous Scientific Society (renamed with effect from 10.10.2011 from DOEACC Society) under the administrative control of Ministry of Electronics and Information Technology (MoEIT), Government of India was set up during November, 1994 to carry out Human Resource Development and related activities in the area of Information & Communications Technology (ICT). The society is registered with Income Tax Department u/s 12A and has been formed exclusively for the purpose to generate quality manpower and develop skilled professionals in the area of Information, Electronics & Communications Technology (IECT) and allied fields, by providing world class education & training and accreditation services. The Society is engaged both in the formal & Non formal Education in the area of Information & Communications Technology (ICT) besides development of Industry oriented quality education and training in the state-of-art areas establish standards to be the Country's premier Institution for Examination and Certification in the field of ICT. It is also a National Examination Body which accredits institutes/organizations for conducting courses particularly in the Non formal Sector of IT Education & training. NIELIT is working through its 20 centres- Aizwal, Aurangabad, Agartala, Ajmer, Calicut, Chandigarh, Chennai, Delhi, Gangtok, Gorakhpur, Guwahati Itanagar, Imphal, Kolkata, Kohima, Patna, Ranchi, Ropar, Shillong, Srinagar & Jammu.

1. ACCOUNTING CONVENTION:

A) Method of Accounting

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated on the accrual method of accounting.

B) Use of Estimates

The preparation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of financial statements and the reported amount of revenues of expenses during the reporting period. Difference between the actual results and estimates are recognized in the period in which the results are known/ materialize

2. INCOME RECOGNITION

All the NIELIT Centers are following accrual method of accounting except:

a) Chennai centre is following cash basis accounting for accreditation fees, Variable accreditation Fees and Awareness Creation Fund.

- Agartala Centre is following cash basis in respect of GIA/Income from NeGD project & ISEA Project-II and receipt from students other than SC/ST Candidates.
- c) Grant towards reimbursement of fees of SC/ST students has been accounted on realization basis by Gorakhpur Centre. Lucknow Extension Centre is following cash basis in receipt of course fee income.
- d) Registration Fee, Accreditation Fee, Variable Accreditation Fee (VAF) and Awareness Creation Fund (ACF) have been recognized on receipts basis.
- 3. The Grant-in-Aid released by the MeitY for setting-up of New Centers for meeting of Recurring Expenditure has been accounted for, as detailed below:-

4. Investments

Funds of the Society invested in Short Term Fixed Deposits with nationalized banks have been shown as per guidelines of the Society for "Treasury Management of Surplus".

Interest on Fixed Deposit kept for Earmarked/ Endowment Fund received during the year, is being credited to respective Earmarked/ Endowment Fund.

5. Fixed Assets

Fixed Assets are stated at cost less accumulated depreciation. Cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses related to acquisition. In respect of project involving construction, related pre- operational expenses, form part of the value of the Assets capitalized.

• In respect of Calicut Centre, the value of equipments consisting of 137 numbers of items given as grant to

the Centre by UNDP have been shown at a notional value of Rs.1/- on both liability and asset side.

- In respect of Kolkata Centre, the "Leasehold Land" at Sector-1 of Bidhannagar (Salt Lake, Plot no. 267, Block-BF) has been shown under the head "Building" in the Fixed Assets schedule. However No Depreciation has been charged on lease hold property.
- In respect of Agartala Centre, 15 Acres of Land for building the permanent campus has been allotted by Govt. of Tripura at free of cost, the same has been shown at the Nominal Value of Re. 1/-. Under the Fixed Assets Schedule.
- In respect of Chandigarh , there was a major fire incident in June, 2014 in the building occupied by NIELIT (formerly RCC) at SCO 114-116, Sector-17-B, Chandigarh. Appropriate accounting entries regarding losses/write-offs in respect thereof have been recorded in the year 2015-16. In the said incident, the Centre lost almost all the records till that date, including Fixed Asset Register.
- In respect of Guwahati Centre, the land allotted by the Govt. of Assam for construction of the permanent campus at free of cost at Guwahati Main (3 acres), Kokrajhar Ext. Centre (6 Acres), Jorhat Ext. Centre (3 Acres), Dibrugarh Ext. Centre (3.3 Acres) and Tezpur Ext. Centre (6.62 Acres) has been shown at nominal value of Rs.1 in each case.
- In respect of NE Capacity Building Project of Silchar & Jorhat Extension Centre, expenditure incurred on renovation of building (Civil & Electricals) taken on rental basis for a period of 4 years has been shown as deferred expenditure to be written off over the period of occupancy. Further, in respect of NIELIT Guwahati (City Centre), expenditure incurred on renovation incurred on renovation of building (Civil & Electricals) taken on rental basis for a period of 10 years has been shown as deferred expenditure to be written off over the period of occupancy.
- The Government of Rajasthan has allotted 16.33 Hectares of land at Village Khoda near Kekri Distt. Ajmer for 99 years lease at free of cost has been shown at the nominal value of Re.1/-.
- Land measuring about 10 acres has been transferred to NIELIT Shillong by Government of Meghalaya as free of cost for a normal term of lease which is for 30 (thirty) years for the purpose of setting up of permanent

campus of NIELIT Shillong. Further, land measuring 2,199.70 sq. mt. has been transferred to NIELIT Tura Extension Centre by Governing of Meghalaya for the purpose of setting up of permanent campus of NIELIT Tura Extension Centre.

- The additional space measuring 5818 Sq Ft. of built up area hired from Meghalaya State Housing Finance Co operative Society (MSHFCS) limited for 4 years for office and for conducting training activities. All expenses relating civil repairing, alteration, electrical works and other miscellaneous expenses relating thereto have been shown as deferred expenditure to be written off over the period of occupancy.
- During the year, NIELIT, Itanagar has opened a new unit Tezu Extension Centre where operation has not yet started till 31.03.2017 and accordingly no depreciation is charged on fixed assets.
- In case of Ropar, the construction work of building of the project is under progress. Training class of Ropar Centre are for the time being run from NIELIT Chandigarh till the time building is not completed. The cost in respect of courses run from NIELIT Chandigarh could not be separately booked. Therefore, manpower cost and other overheads of the Centre have been apportioned on the basis of ratio of manpower cost of the courses run by the Ropar centre viz or viz to total manpower cost of the Chandigarh centre.
- In respect of NIELIT, Aurangabad Centre, payment of Rs.75.00 lakh was made to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad in the year 2013-14 as per MOU for construction of Girls hostel in University campus. The rights of ownership are vested with the University and taking into consideration initial validity of MOU for 5 years, in the circumstances expenditure is treated as "Deferred Revenue Expenditure" and same to be written off over a period of 5 years accordingly Rs.15.00 lakh is appropriated as expenditure for the financial year 2015-16.
- Shillong -Assets namely, Land –Leasehold, Office & Other Equipments and software which have been transferred to NIELIT Shillong as free of cost are taken into account with a Nominal Value at Rs 1/- per item.

6. Depreciation

Depreciation for current year on "Grant related Assets" is debited to Income & Expenditure Account and also credited to Income & Expenditure Account as

per AS-12 and deducted from "Capital Grant-in-Aid" during the year.

Depreciation is provided on W.D.V. method as per rates specified in the Income Tax Act 1961.

8. Change in Accounting Policy

During the year no such changes taken place.

9. Employee's Benefits

Provision for Gratuity is accounted for on actuarial valuation as per AS -15. The liability of Gratuity in respect of Calicut and Chandigarh has been covered by the policy obtained in favor of the respective Employee's Trust under Group Gratuity cash accumulation from LIC of India. NIELIT employees are covered under the existing Gratuity scheme as on 14.12.2002 i.e. on month emoluments (Pay + Grade Pay) for each employee, for each completed year of Service.

Provision of Leave Encashment is accounted for on actuarial valuation basis as per AS-15.

NIELIT HQ and Centers have been covered under EPF w.e.f. 01.01.2003 with the approval of the Competent Authority. EPF Contributions from April, 2013 onwards are being deposited with RPFC. The arrears of EPF for the period from 01.01.2003 to 31.03.2013 has been deposited with EPF Office. The balance lying in NIELIT CPF is being reconciled.

Bonus is accounted on Cash Basis.

1. **Contingent Liability:**

Aurangabad Centre

M/s DVIIT, Aurangabad has filed RCS 495/1999 and SCS 168/2002 before Hon'ble CJSD, Aurangabad against Government of India (DIT through its secretary, New Delhi) as First Party and CEDTI Aurangabad (Presently NIELIT, Aurangabad) through its Director as Second Party and claiming the rendition of Accounts and recovery of Rs. 72.00 Lacs towards its 40% share & interest thereon. The Hon'ble court has passed the order on 5th December, 2011 in both the suits dismissing the claim of the plaintiff with cost.

Thereafter the plaintiff has filed appeal No. 559/2012 (Related to 495/1999) the hearing of which is pending. Also plentiff has submitted an appeal bearing No. 1170/2012 in the Hon'ble High Court of judicature of Bombay, Bench at Aurangabad and presently the matter is pending at Hon'ble High Court.

- Centre had erroneously deposited Service Tax of Rs 74.86 lacs with the Service Tax Department against the bills raised to
 Department of Higher Education (DHE), Govt of HP, Shimla for the period from March 2013 to January 2014. However,
 the Service Tax was not applicable during the period. Accordingly, an amount of Rs 74.86 lacs is recoverable from the
 Service Tax Department and payable to DHE Shimla who have already disputed payment of aforesaid service tax to
 NIELIT. Refund claim for the same was filed on 11.03.2014 with the Service Tax Department which is yet to be settled.
- Another refund application filed for the period from June, 2014 to August, 2015 fo Rs.2,57,77,696/- on the similar facts & grounds has been rejected by the department subsequent to the balance sheet date. Centre is in process of filing an appeal before appropriate authority in this case as well.
- NIELIT, Chandigarh initiated arbitration proceedings against Kendriya Vidyalya Sangathan (KVS) for recovery of dues amounting to Rs.15,66,021/- for providing instructors for school project, appropriate provision in respect of which has already been made in the books as Provision for Doubtful Debts. KVS has not only refuted the claim of the Centre but has also filed a counter-claim of Rs.2,68,650/- as over-payment to the Centre (formerly RCC). Arbitration proceedings are yet to be concluded.
- ESI had issued demand notice for Rs. 11,22,702/- and 303,947/- for ESI scheme which has been got stayed. The Civil Judge (Sr. Division), ESI Court Chandigarh vide order dated 07.12.2010 had set aside the order of ESI for recovery. But the Dy. Director, ESI vide his Order NO. PB 17000399790001013/245 dated 21.07.2011, has again directed this Centre to pay the amount. The centre has filed writ petition with Hon'ble Punjab & Haryana High Court. Hon'ble High Court has stayed the recovery. The matter is still pending.

• Kolkata Centre

RCC Employees Contributory Provident Fund Trust with Income Tax recognition is maintaining PF of employees who have joined NIELIT before 01.01.2004. However, PF of employees who have joined on or after 01.01.2004 is maintained at NIELIT Headquarter under CPF Act 1925. The Centre has received a notice on 11.07.2006 and order u/s.7A dated 09.07.2008 and u/s 7B dated 30.01.2009 from Regional EPF authority that NIELIT will be covered under EPF & MP Act. 1952 from August 1982. Against the above mentioned orders the Centre has filed an appeal to the EPF Appellate Tribunal, Delhi (appropriate authority) that our Head quarter is covered under CPF Act, 1925, as per GOI Gazette Notification dated 26.07.1997. However, the EPF Appellate Tribunal, Delhi has dismissed the appeal by order dated 03rd August, 2011. The Centre has there after filled an appeal with the Honorable High Court, Kolkata against the aforesaid order, on 21st March, 2012. The said appeal is still pending.

The Centre has paid a sum of Rs. 1,56,854/- under protest against demand of Rs.6,27,413/- from Employees State Insurance Corporation West Bengal Region. The demand has been disputed by the Centre.

There is a contingent liability of Rs 19,67,385/regarding service tax as per show cause notice dated 21/10/13 received from Additional Commissioner of Service Tax which has been disputed by the centre vide letter dated 21/04/14.

2. Capital Commitment

 In case of Kolkata Centre there is capital commitment of Salt Lake Building amounting to Rs. 1267.94 Lacs. Advance given to CPWD is Rs 1076.97 Lacs upto 31.03.2017 (Previous year Rs 870.02 Lacs).

- Building is constructed at Lunglei extension centre and at Aizawl centre, total estimated construction cost is Rs 19,22,21,002 out of which Rs 5,57,00,756 has been paid till 31.03.2017.
- In case of Head Quarter, Office space at NBCC Tower, kidwai nagar is being purchased for Rs. 48.36 crores out of which Rs. 25.83 crores has been paid till 31st March, 2017.

During the year 2016-17, the following Centers have made provisions of Rs. 10 crore, out of surplus for the year 2015-16 for meeting the cost of office space for NIELIT Delhi Centre.

In the opinion of the management, the current assets, loans and advances have been stated at the value which will be realizable in the ordinary course of business, except in the case of debtors where provision for Bad & doubtful debts provided for.

In Case of Delhi Centre

A Provision of Rs. 2,16,542/- only for doubtful debts has been made in respect of sundry debtors amounting to Rs 54,88,871/- (Apart from Point stated below) which are outstanding for more than three years. (I.e. before 31.03.2014), which in the opinion of the management is reasonable.

A provision of Rs. 28,11,468/- only has been made towards doubtful debts against recoverable of Rs. 1,12,71,327/- from Director of Education, Jhandewalan. This amount is due since 2004-05. The matter is under arbitration. in the opinion of the management quantum of provision made is reasonable.

In case of Chandigarh Centre

The Centre surrendered Land allotted by Municipal Corporation, Chandigarh (MCC) in January, 2002 and amount of Rs.43.24 lakh paid as 25% deposit against the said land was claimed as an appeal before the Chief Administrator, Chandigarh. The same was dismissed except for reducing the forfeiture amount from 25% to 15%. Centre is in process of filing fresh writ petition for refund of forfeited amount of Rs.43.24 lakh and the management is hopeful of favorable outcome of the dispute. However, keeping in view the concept of prudence, a provision of 50% of the total recoverable amount i.e. Rs.21,62,023/- has been made during the year as provision for Doubtful Debts.

The Centre had signed an MOU in July, 2003 with National Council for Promotion of Urdu Language, New Delhi(NCPUL), for implementing one year course on Diploma in Computer Applications and Multilingual DTP. An amount of Rs.32.14 lakh is still receivable for the year 2006-07 due to certain objections by NCPUL in this regard. The matter is under correspondence with NCPUL and the management is reasonably hopeful of recovery of the said dues, however, considering the longevity of the dues, 50% of the total amount i.e. Rs.16,06,800/- has been provided as Provision for Doubtful Debts, during the year under review.

- Shillong Centre has given an amount of Rs.2,86,50,000/-(Rupees Two Crores Eighty Six Lakhs Fifty Thousand only) to Project Management Consultant (PMC) as "Mobilization Advance"
- Delhi Development Authority has allotted a plot measuring 4277.88 sq mtr to NIELIT at Sector 8 Dwarka, New Delhi for construction of its HQ's.. Final Cost of the land is yet to be finalized by DDA.

5. National Population Register (NPR)

- a) Department of Electronics, Information & Technology vide its letter bearing No: FNo7(2)2011-EG-1 dated 05/04/2011 has entrusted the work of Demographic Data Digitisation & Bio-metric data collection for creating National Population Register(NPR) in respect of 17 States & 2 Union Territories . RGI vide its DO No;9/83/2010-CRD(NPR) dated 27.06.2012 has withdrawn the work of Bio-Metric data digitisation from NIELIT.
- b) Office of the Registrar General of India had released an advance of Rs 522.24 crore to the NIELIT for execution of National Population Register Project. Total cost towards Data Digitisation (NPR Project) stands at appx Rs 569 core.As per payment terms of RFQ ,balance 30% payment to MSP's has not been released. As on 31.03.2017,an amount of Rs 246.10 crore has already been utilized. The balance amount of Rs 486.56 crore is available(Including interest) in various bank Accounts(Saving/Current) and in the form of Deposits
- c) The work of Data digitisation has been completed. The last Digitised Data has been handed over to RGI during October.2013
- d) Separate Books of Accounts have been maintained by all the NPR participating NIELIT Centres w.e.f 01.04.2012 in respect of NPR project & prepared separate Annual Account from the F.Y. 2012-13.

- e) Interest amounting to Rs 211.56 Crore Earned/ Accrued on unutilised Advance has been earmarked under Liabilities and not accounted for as Interest Income in the absence of guide lines from RGI.
- f) An advance of Rs 29.29 Crore paid to M/S CSC-SPV for monitoring and supervising the work of data digitisation in rural zones has been adjusted in the NPR books at HQ, consequent to approval accorded by the competent authority and expenditure accounted for in the books of respective NPR participating NIELIT Centres. M/S CSC-SPV has incurred an expenditure of Rs 29.70 Crore upto 31.03.2017 towards cost of monitoring and supervising the work of data digitisation in rural Zones. Provision for balance amount of Rs .41 Crore has been made in NPR books at HQ
- g) Major fire broke out during June 2014 in the office building of NIELIT Centre Chandigarh, due to which all infrastructures and Centre records have been destroyed.NPR assets amounting to Rs 33,97,366/-(Net Block Rs.8,37,687/-) was lost in the fire. During financial year 2015-16, NIELIT Centre Chandigarh has received claim of Rs.7,09,149/- from Insurance company and accordingly adjustment carried out in the books of accounts.
- h) As per terms of the RFQ, there was a clause charging penalty of even more than 100% of the invoice amount of the MSP's in case of non adherence of compliance of any terms of the RFQ. Since there has been delay in completion of data digitization work, some of the parties have not raised the bills. In the absence of bills raised by the parties for the services rendered by them, liability/ penalty thereof cannot be ascertained. The same will be accounted for in the year in which the bills are received.
- 6. We hereby confirm that the society has no amount payable to Micro Small & Medium Enterprises as defined in section 7(1) of the Micro Small & Medium Enterprises Act, 2006, to the extent such parties identified on the basis of information collected by the management.
- 7. Previous year figures have been regrouped or rearranged wherever necessary.
- 8. The figures have been rounded off to the nearest Rupees.
- 9. Debtors & Creditors are stated in the books at the value which is recoverable/ payable. However, the confirmation from the parties is under process.
- 10. During consolidation of various centers, heading/ groups have been re-arranged for better and fair presentation.
